# **Instructions for Form REV-1784**

Pennsylvania Boat Dealer's Report of Sales of Boats Which Are Delivered by the Seller Out-Of-State

REV-1784 IN (DR) 10-20

### **GENERAL INFORMATION**

#### **BOAT**

Any motorized or nonmotorized watercraft having a capacity of 1,000 pounds or more as evidenced by the capacity plate.

#### **BOAT DEALER**

Any person engaged in the business of selling and/or leasing boats in Pennsylvania.

It is presumed that all sales of boats are subject to sales tax unless the boat dealer or purchaser provides adequate proof that the sale is not taxable. The PA Department of Revenue requires the completion of this form by any boat dealer for all sales of boats, as described above, which are delivered out of state.

### **LINE INSTRUCTIONS**

### **SECTION I**

#### **DEALER INFORMATION**

Print or type dealer name, PA sales tax license number, address, city, county, state and ZIP code.

### **SECTION II**

#### **PURCHASER INFORMATION**

Print or type purchaser's name, drivers license number (including state), date of purchase, address, city, county, state and ZIP code. Include name of co-owner if applicable.

#### **SECTION III**

### **BOAT IDENTIFICATION INFORMATION**

Print or type builder name, model, year, length, hull identification number, engine manufacturer, engine identification number, engine horsepower, and purchase price (without trade). Include boat, motor, accessories and freight excluding trailer with purchase price.

#### **SECTION IV**

### **BOAT TRAILER IDENTIFICATION INFORMATION**

Print or type state of registration, registration number and purchase price.

#### **SECTION IV**

#### **USE INFORMATION**

Print or type city or town and state boat will be delivered by the seller. Check whether the boat will be documented or registered and list the state of registration.

Print or type the storage address where the boat will be primarily used or moored. Include Marina with slip number and/or body of water.

Print or type the boats storage location in non-use months, for example winter storage. Please identify the city/town and state of storage location.

#### **SECTION VI**

### **CERTIFICATION**

Dealer must sign and date along with the purchaser, and copurchaser if applicable.

**IMPORTANT:** Boat dealers maybe held liable for the sales tax plus charges for penalty and interest when adequate proof of exemption is not available.

Execute this form in triplicate:

- Give one copy to the customer.
- Retain one copy for your records. This copy must be available for audit by officials of the PA Department of Revenue.
