The garnishment of wages in order to pay a state tax liability is authorized by Act No. 46 of 2003 (72 P.S. § 10003.15), effective December 23, 2003. This Act allows 10 percent of your gross pay to be deducted from each subsequent pay period until your Outstanding Income Tax Liability has been satisfied.

What you need to do

To avoid wage garnishment, you must do one of the following within 30 days of the Date Issued printed on this notice.

- Pay Your Debt
- Set Up a Formal Payment Plan with the Department
- Provide Proof of Petition
- Provide Proof of Bankruptcy

If you have filed for bankruptcy, an automatic bankruptcy stay is in effect, or you believe that some of your liability has been discharged by a court order, please submit a copy of your court order.
