PA-20S/PA-65 ANNUAL PAYMENT VOUCHER

**FEDERAL EMPLOYER IDENTIFICATION NUMBER (FEIN)**

FEIN - enter the nine-digit FEIN, with a hyphen, of the entity.

**AFTER THE FEIN**

Enter C for PTE Payment for PA-20S/PA-65

Enter G for NRC Payment for PA-40 NRC

**CHECK DIGIT**

Print the first two letters of the entity name.

**VOUCHER TYPE**

Enter PA-20S/PA-65 or PA-40 NRC

**BUSINESS NAME**

Print the complete name of the entity.

**ADDRESS**

- First and Second Line of Address— Print the complete street address of the entity. If the address has an apartment, suite or RR number, enter after the street address.
- City – Print the name of the city. For foreign addresses, the bottom line of the address should show only the country name written in full (no abbreviations) and in capital letters.
- State – Print the two-digit state abbreviation.
- ZIP – Print the five-digit ZIP Code.

**PHONE NUMBER**

Print the 10-digit phone number of the entity with area code including hyphens.

**FISCAL YEAR**

- If the entity does not file on a calendar-year basis, enter Y.
- Do not enter Y if the entity is a calendar-year filer that is filing a short-year return.

**SHORT YEAR**

- If the entity is filing a short year return, enter Y.
- A short year is an accounting period shorter than one year and not a 52-53 week taxable year.

**BEGIN DATE**

- If you answered "Y" to FISCAL YEAR or SHORT YEAR.
- Enter the month, day and year (MMDDYY) when the fiscal or short year begins.

**END DATE**

- If you answered "Y" to FISCAL YEAR or SHORT YEAR.
- Enter the month, day and year (MMDDYY) when the fiscal or short year ends.

**PAYMENT**

**Electronic Funds Transfer**

Payments for 2022 PA tax due may be made using electronic funds transfer by accessing myPATH at mypath.pa.gov. When prompted, enter the bank account information and the payment will be deducted from the account on the date specified. There is no charge for using this option.



**NOTE:** Payments equal to or greater than \$15,000 **must** be made electronically. Payments not made electronically will be subject to a penalty equal to 3% of the payment amount not to exceed \$500.

**Check or Money Order**

Make the check or money order payable to the PA DEPT. OF REVENUE. Please write on the check or money order:

- The FEIN of the entity.
- "2022 NONRESIDENT WITHHOLDING PAYMENT".

The department will need the FEIN to accurately apply the payment if the check becomes separated from the PA-20S/PA-65 V.
