- **5.** Boat purchased out-of-state, by a nonresident, more than six months prior to being brought into Pennsylvania by a nonresident, in connection with establishment of a permanent business or residence: Indicate date of purchase (see top of REV-336).
- **6.** Boat transferred to applicant without consideration or value. Consideration includes the amount of any existing encumbrance or other obligation assumed in connection with the transfer.

Local Sales Tax:
