I hereby certify, pursuant to Article XIX-B of the Tax Reform Code, \$87,336,694.03 in General Fund revenue is attributable to the Neighborhood Improvement Zone for program year 2022.

The amount of state taxes paid, less any state tax refunds received, by qualified businesses and contractors filing reports with the Department of Revenue and attributable to the Neighborhood Improvement Zone between January 1 and December 31, 2022, total \$87,188,819.81.
