

Monthly Revenue Report March 2002

General Fund

General Fund collections of \$2,719.2 million in March fell short of the monthly estimate by \$263.4 million, or 8.8%. Year-to-date collections total \$14,567.3 million, which are \$749.3 million, or 4.9%, below the official estimate.

- Total Corporation Taxes of \$1,502.3 million for the month of March fell short of the official estimate by \$201.8 million, or 11.8%. Year-to-date collections are \$345.0 million, or 11.3%, below the official estimate.
- Total Sales and Use Tax (SUT) collections of \$518.5 million were \$21.2 million, or 3.9%, below the official estimate. Year-to-date SUT collections are \$23.2 million, or 0.4%, below estimate and are 1.0% above the prior year.
- Total Personal Income Tax (PIT) collections of \$518.5 million for the month fell short of the official estimate by \$34.2 million, or 6.2%. Year-to-date PIT collections are \$298.3 million, or 5.7%, below estimate due primarily to lower than anticipated PIT withholding payments.
- Realty Transfer Tax (RTT) collections of \$21.8 million were \$2.9 million, or 15.1%, above the official estimate for March. Year-to-date collections are \$5.5 million, or 2.6%, above estimate and are 6.3% above the prior year.
- Total Inheritance Tax collections of \$63.5 million for the month of March exceeded the official estimate by \$2.4 million, or 3.9%. Year-to-date collections are \$15.0 million, or 2.6%, above the official estimate and are 1.9% above the prior year.
- Nontax revenue collections of \$56.7 million for the month of March fell short of the official estimate by \$13.5 million, or 19.2%. Year-to-date collections of \$341.6 million are 24.0% below estimate. This shortfall is primarily the result of lower than anticipated Treasury receipts.

Motor License Fund

Motor License Fund collections of \$162.9 million in March were \$4.7 million, or 3.0%, above the official estimate. Year-to-date collections total \$1,479.8 million and are 2.1% above estimate.

• Total Liquid Fuels Taxes of \$81.9 million exceeded the official estimate for the month by \$3.3 million, or 4.2%. Year-to-date collections of \$870.5 million are \$26.7 million, or 3.2%, above estimate





Comparison of Cumulative Tax Refunds










Monthly Revenue Receipts

Cumulative Differences from Official Estimate and Prior Year Collections













Motor License Fund Cumulative Differences from Official Estimate and Prior Year Collections
