

# Monthly Revenue Report April 2003

Commonwealth of Pennsylvania Department of Revenue

# General Fund

General Fund collections of \$2,473.7 million in April fell short of the monthly estimate by \$89.4 million, or 3.5%. Year-to-date collections total \$17,849.8 million, which are \$361.2 million, or 2.0%, below the official estimate.

- Total Corporation Taxes of \$444.3 million for the month of April fell short of the official estimate by \$45.0 million, or 9.2%. Year-to-date collections are \$130.9 million, or 3.8%, below estimate and are 5.4% above the prior year.
- Total Sales and Use Tax (SUT) collections of \$633.9 million for April were \$11.5 million, or 1.8%, below estimate. Year-to-date SUT collections are \$18.6 million, or 0.3%, below estimate and are 2.8% above the prior year.
- Personal Income Tax (PIT) collections of \$1,017.0 million for April fell short of the official estimate by \$26.5 million, or 2.5%. Year-to-date PIT collections are \$216.9 million, or 3.5%, below estimate.
- Realty Transfer Tax (RTT) collections of \$28.3 million for the month exceeded the official estimate by \$3.2 million, or 12.7%. Year-to-date collections are \$36.3 million, or 13.6%, above estimate.
- Inheritance Tax collections of \$57.8 million for the month of April fell short of the official estimate by \$13.5 million, or 19.0%. Year-to-date collections are \$54.5 million, or 8.5%, below the official estimate.
- Nontax revenue collections of \$198.7 million exceed the monthly estimate by \$10.0 million, or 5.3%. Year-to-date collections of \$555.0 million are \$12.3 million, or 2.3%, above the official estimate due primarily to higher than anticipated Escheats receipts. An expected transfer of funds related to the Act 90-2002 increase in the landfill tipping fee is included in the April License and Fees estimate at \$21 million. This transfer did not occur in April and is now expected in May.

# Motor License Fund

Motor License Fund collections of \$179.3 million in April were \$1.0 million, or 0.5%, below the official estimate. Year-to-date collections of \$1,678.8 million are \$27.9 million, or 1.6%, below estimate.

• Total Liquid Fuels Tax collections of \$95.4 million exceeded the official estimate by \$5.4 million, or 6.0%. Year-to-date collections are \$4.3 million, or 0.4%, below estimate.










**Cumulative Differences from Official Estimate and Prior Year Collections** 







