

# Monthly Revenue Report May 2003

Commonwealth of Pennsylvania Department of Revenue

# **General Fund**

General Fund collections of \$1,466.8 million in May fell short of the monthly estimate by \$94.3 million, or 6.0%. Year-to-date collections total \$19,316.7 million, which are \$455.4 million, or 2.3%, below the official estimate.

- Total Corporation Taxes of \$49.6 million for the month of May fell short of the official estimate by \$31.2 million, or 38.6%. Year-to-date collections are \$162.1 million, or 4.6%, below estimate and are 4.8% above the prior year.
- Total Sales and Use Tax (SUT) collections of \$633.0 million for May were \$9.3 million, or 1.5%, above estimate. Year-to-date SUT collections are \$9.3 million, or 0.1%, below estimate and are 2.9% above the prior year.
- Personal Income Tax (PIT) collections of \$496.2 million for May fell short of the official estimate by \$48.0 million, or 8.8%. Year-to-date PIT collections are \$264.9 million, or 3.9%, below estimate.
- Realty Transfer Tax (RTT) collections of \$26.8 million for the month exceeded the official estimate by \$0.3 million, or 1.0%. Year-to-date collections are \$36.6 million, or 12.4%, above estimate.
- Inheritance Tax collections of \$56.9 million for the month of May fell short of the official estimate by \$17.6 million, or 23.7%. Year-to-date collections are \$72.2 million, or 10.1%, below the official estimate.
- Nontax revenue collections of \$111.8 million for the month of May fell short of the official estimate by \$6.8 million, or 5.7%. Year-to-date collections of \$666.8 million are \$5.5 million, or 0.8%, above the official estimate. A transfer of funds related to the Act 90-2002 increase in the landfill tipping fee was expected in the April License and Fees collections, but was not actually received until May. This transfer totaled \$10.3 million.

# Motor License Fund

Motor License Fund collections of \$197.7 million in May were \$15.5 million, or 7.3%, below the official estimate. Year-to-date collections of \$1,876.6 million are \$43.4 million, or 2.3%, below estimate.

• Total Licenses and Fees collections of \$100.5 million fell short of the official estimate by \$2.5 million, or 2.4%. Year-to-date collections are \$0.8 million, or 0.1%, below estimate.

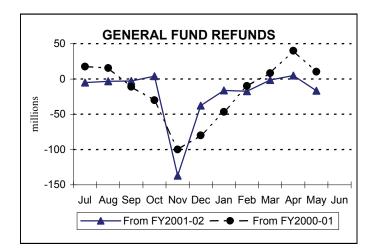

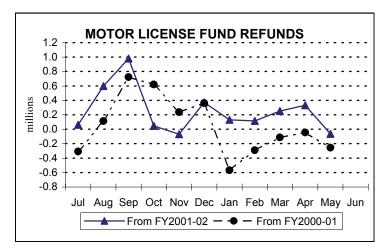

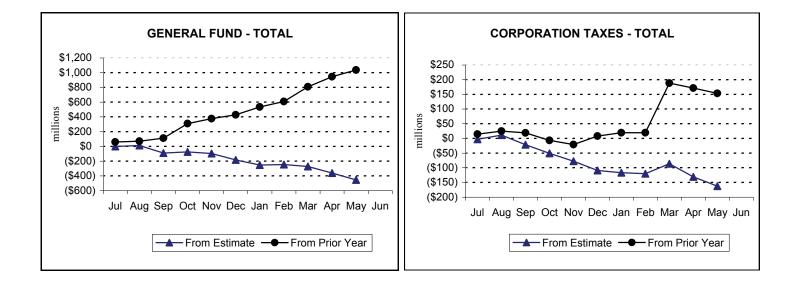


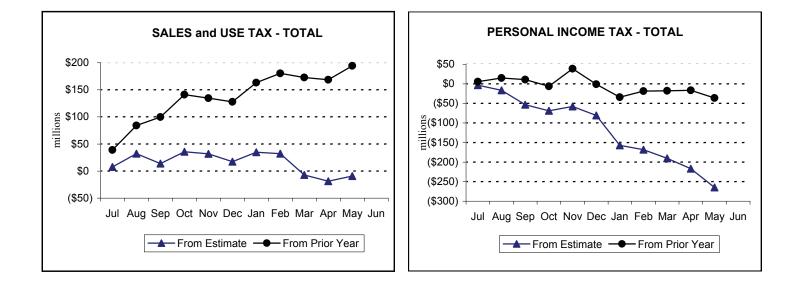




## GENERAL FUND Monthly Revenue Receipts

**Cumulative Differences from Official Estimate and Prior Year Collections** 

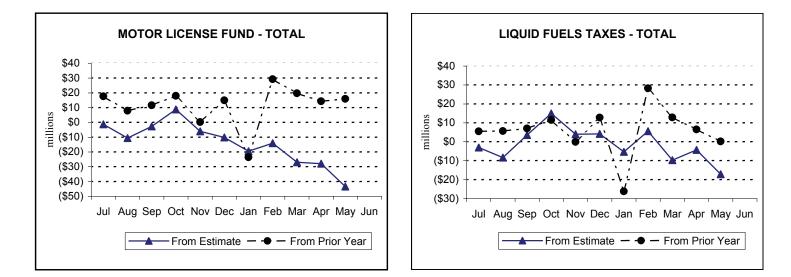




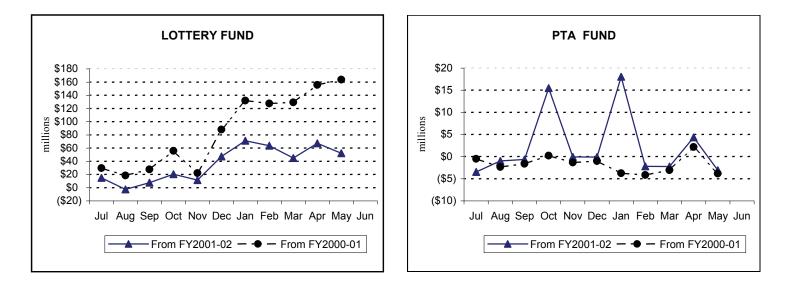
