

Monthly Revenue Report June 2004

Commonwealth of Pennsylvania Department of Revenue

General Fund

General Fund collections of \$2,136.8 million for the month of June were \$180.4 million, or 9.2%, above the official estimate. Fiscal year 2003-04 collections of \$22,828.1 million, exceeded the official estimate by \$636.8 million, or 2.9%.

- Total Corporation Taxes of \$4,351.1 million for the fiscal year were above estimate by \$251.8 million, or 6.1%.
- Sales and Use Tax (SUT) revenues for the fiscal year totaled \$7,728.5 million, which was 0.4% above estimate. Total 2003-04 SUT collections were 2.8% above the previous fiscal year, with non-motor vehicle and motor vehicle receipts growing at a rate of 3.0% and 1.8%, respectively.
- Total Personal Income Tax (PIT) collections of \$7,733.8 million for fiscal year 2003-04 were \$117.8 million, or 1.5%, above estimate.
- Realty Transfer Tax (RTT) collections of \$400.6 million for fiscal year 2003-04 were \$25.9 million, or 6.9%, above the official estimate.
- Total Inheritance Tax collections of \$747.6 million for the fiscal year were \$43.3 million, or 6.2%, above estimate.
- Other tax revenue, including Cigarette, Malt Beverage, Liquor, and other miscellaneous tax collections totaled \$1,084.5 million for the fiscal year.
- Total nontax revenue collections of \$782.0 million for fiscal year 2003-04 exceeded the official estimate by \$159.0 million.

Motor License Fund

Motor License Fund collections of \$120.2 million in June fell short of the official estimate \$2.2 million, or 1.8%. Fiscal year 2003-04 collections totaled \$2,085.6 million, which were \$59.3 million, or 2.9%, above the official estimate.

- Liquid Fuels Tax collections of \$1,113.0 million for the fiscal year fell short of the official estimate by \$6.6 million, or 0.6%.
- Total Licenses and Fees collections of \$843.2 million for the fiscal year were \$5.8 million, or 0.7%, above the official estimate.









Comparison of Cumulative Tax Refunds



GENERAL FUND Monthly Revenue Receipts


Cumulative Differences from Official Estimate and Prior Year Collections




