

Monthly Revenue Report December 2005

Commonwealth of Pennsylvania Department of Revenue

General Fund

General Fund collections of \$2,069.2 million for the month of December were \$78.5 million, or 3.9%, above the official estimate. Fiscal year 2005-06 collections of \$10,879.3 million exceed the official estimate by \$170.5 million, or 1.6%.

- Total Corporation Tax collections of \$517.5 million for the month of December were \$53.3 million, or 11.5%, above the official estimate. Year-to-date collections are \$118.6 million, or 8.8%, above estimate.
- Sales and Use Tax (SUT) collections of \$651.9 million for the month of December were \$12.1 million, or 1.8%, below estimate. Year-to-date collections are \$36.6 million, or 0.9%, below estimate.
- Total Personal Income Tax (PIT) collections of \$666.8 million for the month were \$15.9 million, or 2.4%, above estimate. Year-to-date collections are \$63.7 million, or 1.6%, above estimate.
- Realty Transfer Tax (RTT) revenues of \$47.3 million were \$3.0 million, or 6.8%, above estimate. Year-to-date collections are \$27.3 million, or 10.2%, above estimate.
- Total Inheritance Tax collections of \$61.8 million were \$1.3 million, or 2.1%, above estimate. Year-to-date collections are \$6.8 million, or 1.9%, below estimate through December 2005.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, and other miscellaneous tax collections totaled \$96.9 million for December.
- Nontax revenue collections of \$27.0 million for the month of December were \$7.4 million above the official estimate. Year-to-date collections are \$9.7 million, or 6.3%, below estimate.

Motor License Fund

Motor License Fund collections of \$171.4 million in December were \$5.7 million, or 3.4%, above the official estimate. Fiscal year 2005-06 collections total \$1,150.6 million, and are \$4.0 million, or 0.3%, below estimate.

- Total Liquid Fuels collections of \$99.5 million for December were \$1.0 million, or 1.0%, above estimate. Year-to-date collections are \$7.5 million, or 1.1%, below the official estimate.
- Total Licenses and Fees collections of \$58.0 million for the month of December were \$0.5 million, or 0.8%, above estimate. Year-to-date collections are \$4.5 million, or 1.2%, below estimate.

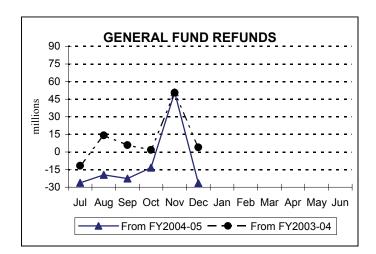

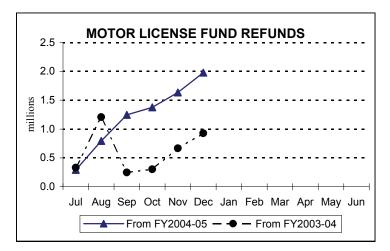

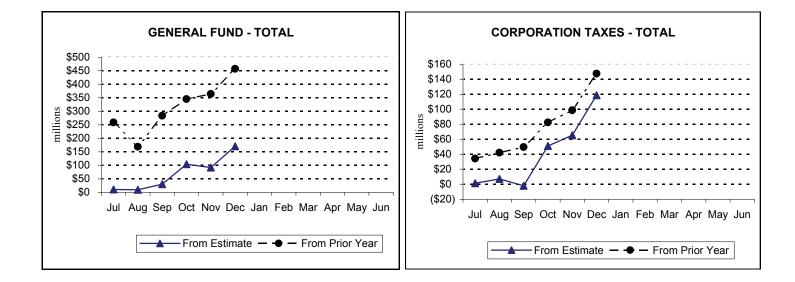


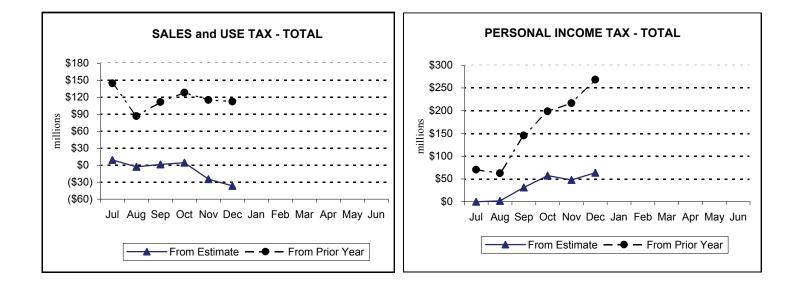


Comparison of Cumulative Tax Refunds

Cumulative Differences from Official Estimate and Prior Year Collections

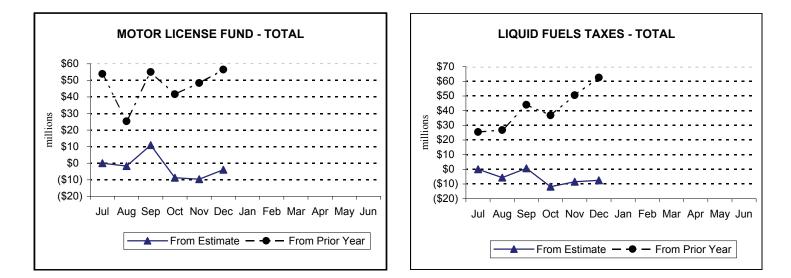




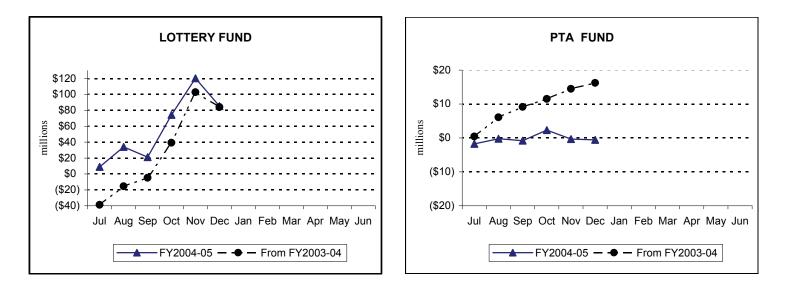
