

Monthly Revenue Report October 2006

General Fund

General Fund collections of \$1,786.1 million for the month of October were \$103.4 million, or 5.5%, below the official estimate. Fiscal year 2006-07 collections of \$7,569.7 million are below the official estimate by \$47.7 million, or 0.6%, through October.

- Total Corporation Tax collections of \$166.2 million for the month were \$64.4 million, or 27.9%, below the official estimate. The October shortfall will be largely offset by a \$50.4 million settlement payment that was receipted on November 2. Year-to-date collections through October are \$16.1 million, or 1.8%, below the official estimate.
- Sales and Use Tax (SUT) revenues of \$741.3 million were below the official estimate by \$11.0 million, or 1.5%, in October. Year-to-date SUT collections are \$10.5 million, or 0.4%, below the official estimate.
- Total Personal Income Tax (PIT) collections of \$646.8 million for the month of October were \$20.1 million, or 3.0%, below estimate. Year-to-date collections are \$8.8 million, or 0.3%, above the official estimate.
- Realty Transfer Tax (RTT) revenues of \$48.3 million fell short of the official estimate by \$4.4 million, or 8.3%, in October. Year-to-date collections are \$7.9 million, or 3.6%, below estimate.
- Total Inheritance Tax collections for the month of October were \$55.8 million, or 15.3%, below estimate. Year-to-date collections are \$24.6 million, or 9.4%, below estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, and other miscellaneous tax collections totaled \$87.1 million for October.
- Nontax revenue collections of \$40.6 million for the month of October exceeded the official estimate by \$11.0 million, or 37.2%. Year-to-date collections are \$5.2 million, or 4.8%, above estimate.

Motor License Fund

Motor License Fund collections of \$184.6 million for the month of October were \$10.9 million, or 6.3%, above the official estimate. Fiscal year 2006-07 collections of \$838.1 million are meeting estimate through the month of October.

• Total Liquid Fuels collections of \$96.8 million for October were \$4.3 million, or 4.7%, above estimate. Year-to-date collections are \$5.4 million, or 1.1%, above the official estimate.





Comparison of Cumulative Tax Refunds










Monthly Revenue Receipts

Cumulative Differences from Official Estimate and Prior Year Collections













Motor License Fund Cumulative Differences from Official Estimate and Prior Year Collections
