

Monthly Revenue Report March 2007

Commonwealth of Pennsylvania Department of Revenue

General Fund

General Fund collections of \$4,028.3 million for the month of March were \$138.4 million, or 3.6%, above the official estimate. Fiscal year 2006-07 collections of \$19,327.6 million are above the official estimate by \$250.5 million, or 1.3%, through March.

- Total Corporation Tax collections of \$2,388.3 million for the month were \$180.6 million, or 8.2%, above the official estimate. Year-to-date collections through March are \$263.1 million, or 6.8%, above the official estimate.
- Sales and Use Tax (SUT) revenues of \$626.2 million were below the official estimate by \$12.1 million, or 1.9%, in March. Year-to-date SUT collections are \$39.5 million, or 0.6%, below the official estimate.
- Total Personal Income Tax (PIT) collections of \$746.6 million for the month of March were \$22.1 million, or 3.1%, above estimate. Year-to-date collections are \$89.3 million, or 1.3%, above the official estimate.
- Realty Transfer Tax (RTT) revenues of \$45.3 million were above the official estimate by \$0.6 million, or 1.5%, in March. Year-to-date collections are \$25.6 million, or 5.6%, below estimate.
- Total Inheritance Tax collections for the month of March were \$76.4 million, or 10.8%, above estimate. Year-to-date collections are \$20.2 million, or 3.5%, below estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, and other miscellaneous tax collections totaled \$78.1 million for March.
- Total nontax revenue collections of \$321.9 million through March 2007 fell below the official estimate by \$12.5 million, or 3.7%. The transfer of Liquor Store Profits scheduled for March did not occur.

Motor License and Gaming Funds

Motor License Fund collections of \$189.9 million for the month of March were \$9.4 million, or 4.7%, below the official estimate. Fiscal year 2006-07 collections of \$1,740.6 million are below the official estimate by \$8.0 million, or 0.5%, through the end of March.

The State Gaming Fund collected \$26.9 million in March. Fiscal year-to-date collections for the Fund total \$371.2 million.

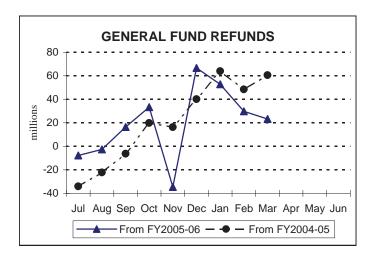

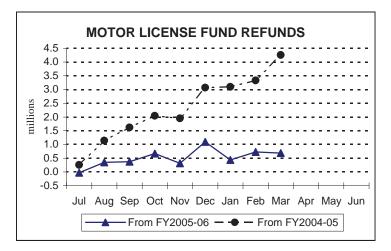

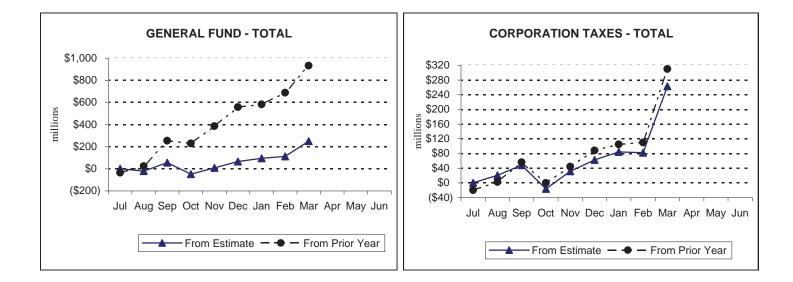


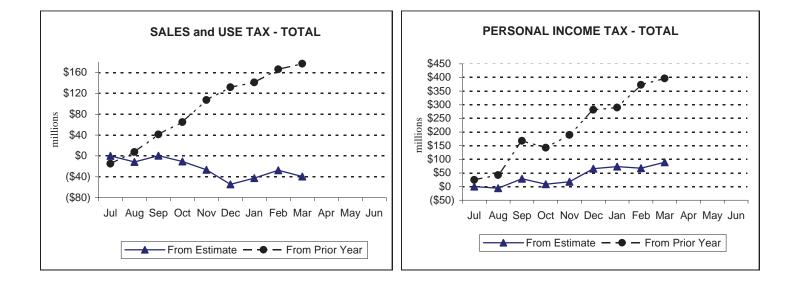
Comparison of Cumulative Tax Refunds

Cumulative Differences from Official Estimate and Prior Year Collections

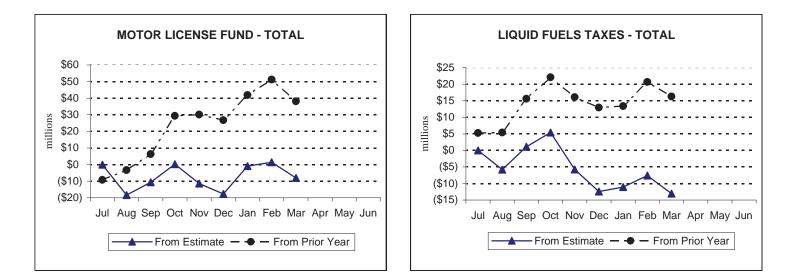




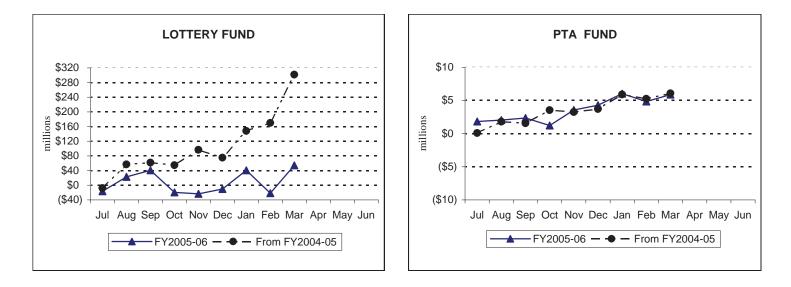
