

## Monthly Revenue Report December 2007

Commonwealth of Pennsylvania Department of Revenue

## General Fund

# General Fund collections of \$2,235.2 million for the month of December were \$39.9 million, or 1.8%, above the official estimate. Fiscal year 2007-08 collections of \$11,693.4 million exceeded the official estimate by \$175.8 million, or 1.5%.

- Total Corporation Tax collections of \$561.0 million for the month of December were \$62.2 million, or 12.5%, above estimate. Year-to-date collections are \$110.4 million, or 7.7%, above estimate. Corporation tax collections for December were affected by the implementation of Act 119-2006. Specifically, this report shows a large amount of corporation tax revenue in "Accelerated Deposits" that would usually be allocated to the specific corporation tax types and to Fines, Penalties, and Interest on Taxes. Due to the implementation of Act 119-2006, that breakout of funds was not possible this month. Total General Fund collections are correct as shown in this report. The breakdown of Accelerated Deposits for December payments will be published as soon as the funds can be distributed.
- Sales and Use Tax (SUT) revenues of \$679.4 million for the month of December were above the official estimate by \$4.5 million, or 0.7%. Year-to-date collections are \$31.4 million, or 0.7%, above estimate.
- Total Personal Income Tax (PIT) collections of \$797.6 million for the month of December were \$19.2 million, or 2.5%, above estimate. Year-to-date collections are \$33.2 million, or 0.7%, above estimate.
- Realty Transfer Tax (RTT) revenues of \$24.2 million for the month of December were \$10.8 million, or 30.8%, below estimate. This shortage includes a \$6.9 million posting error in November that was corrected in December. Year-to-date collections are \$11.8 million, or 5.0%, above estimate.
- Nontax revenue collections of \$20.6 million for the month of December were below the official estimate by \$24.8 million, or 54.7%. Year-to-date collections are \$26.0 million, or 11.1%, below estimate.

#### Motor License and Gaming Funds

Motor License Fund collections of \$160.3 million in December were \$11.7 million, or 6.8%, below the official estimate. Fiscal year 2007-08 collections of \$1,251.1 million are below the official estimate by \$16.8 million, or 1.3%.

The State Gaming Fund collected \$29.3 million in December. Fiscal year-to-date collections for the Fund total \$459.0 million.










**Cumulative Differences from Official Estimate and Prior Year Collections** 







