

Monthly Revenue Report March 2008

Commonwealth of Pennsylvania Department of Revenue

General Fund

General Fund collections of \$3,976.0 million for the month of March were \$109.8 million, or 2.7%, below the official estimate. Fiscal year 2007-08 collections of \$19,788.1 million exceeded the official estimate by \$180.5 million, or 0.9%.

- Total Corporation Tax collections of \$2,344.1 million for the month of March were \$110.9 million, or 4.5%, below estimate. Year-to-date collections are \$96.1 million, or 2.3%, above estimate.
- Sales and Use Tax (SUT) revenues of \$621.9 million for the month of March were above the official estimate by \$8.0 million, or 1.3%. Year-to-date collections are \$27.7 million, or 0.4%, above estimate.
- Total Personal Income Tax (PIT) collections of \$785.5 million for the month of March were \$26.2 million, or 3.5%, above estimate. Year-to-date collections are \$82.5 million, or 1.2%, above estimate.
- Realty Transfer Tax (RTT) revenues of \$24.5 million for the month of March were \$5.6 million, or 18.5%, below estimate. Year-to-date collections are \$2.3 million, or 0.7%, above estimate.
- Total Inheritance Tax collections of \$66.4 million for the month of March were below the official estimate by \$5.2 million, or 7.3%. Year-to-date collections are \$11.9 million, or 2.0%, above estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, and other miscellaneous tax collections totaled \$81.5 million for March.
- Nontax revenue collections of \$52.1 million for the month of March were below the official estimate by \$16.1 million, or 23.6%. Year-to-date collections are \$47.6 million, or 13.6%, below estimate.

Motor License and Gaming Funds

Motor License Fund collections of \$193.4 million in March were \$6.8 million, or 3.4%, below the official estimate. Fiscal year 2007-08 collections of \$1,946.7 million are below the official estimate by \$31.4 million, or 1.6%.

The State Gaming Fund collected \$44.0 million in March. Fiscal year-to-date collections for the Fund total \$588.1 million.

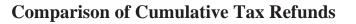

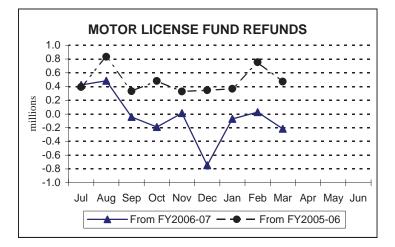

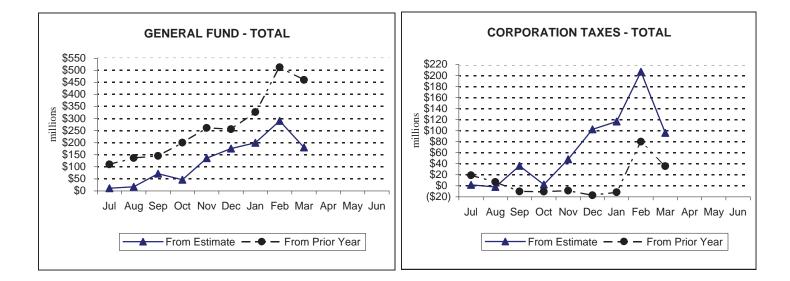

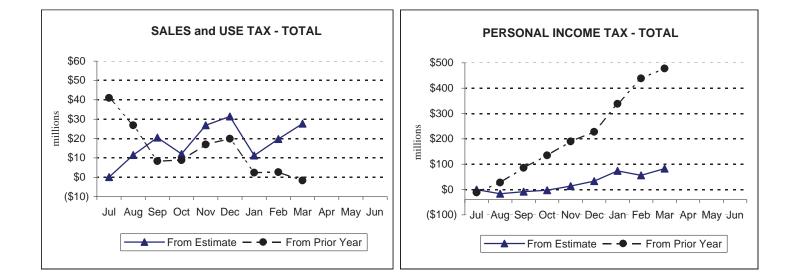




GENERAL FUND Monthly Revenue Receipts

Cumulative Differences from Official Estimate and Prior Year Collections

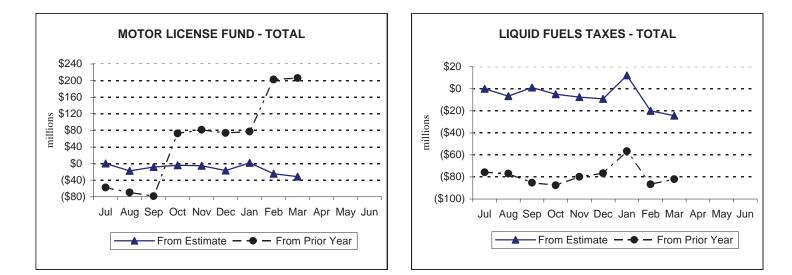




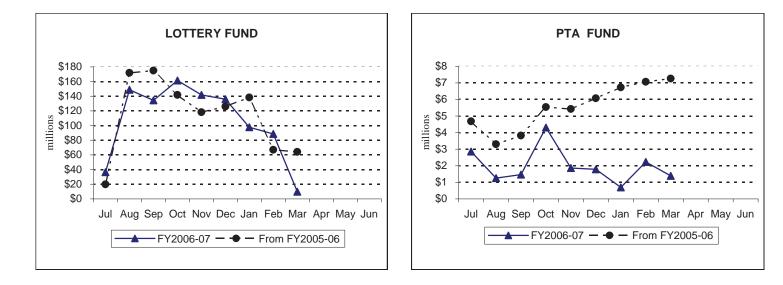
