## GENERAL FUND

General Fund collections of $\$ \mathbf{2 , 0 3 8} .5$ million for the month of October were $\$ 71.5$ million, or $3.6 \%$, above the official estimate. Fiscal year 2012-13 collections of $\$ 8,107.3$ million were above the official estimate by $\$ 82.2$ million, or 1.0\%.

- Total Corporation Tax collections of $\$ 164.4$ million for the month of October were $\$ 49.7$ million, or $43.3 \%$, above the official estimate. Year-to-date collections are \$136.1 million, or $18.6 \%$, above estimate.
- Sales and Use Tax (SUT) collections of $\$ 755.3$ million were $\$ 2.9$ million, or $0.4 \%$, below estimate. Year-to-date collections are $\$ 73.2$ million, or $2.4 \%$, below estimate.
- Total Personal Income Tax (PIT) collections of $\$ 867.6$ million for the month of October were $\$ 14.5$ million, or $1.7 \%$, above estimate. Year-to-date collections are $\$ 38.9$ million, or $1.2 \%$, above the official estimate.
- Realty Transfer Tax (RTT) revenues of $\$ 31.8$ million were $\$ 6.9$ million, or $27.9 \%$, above estimate. Year-to-date collections are $\$ 4.8$ million, or $4.2 \%$, above estimate.
- Inheritance Tax revenues of $\$ 67.2$ million were $\$ 7.2$ million, or $9.7 \%$, below estimate. Year-to-date collections are $\$ 25.2$ million, or $8.9 \%$, below estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Table Games, and other miscellaneous tax collections totaled $\$ 125.7$ million for the month of October.
- Nontax revenue collections for the month of October were above the official estimate by $\$ 13.8$ million. Year-to-date collections are $\$ 17.8$ million above the official estimate. $\mathrm{M}^{2}-\mathrm{m}^{2}$

## MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of $\$ 218.6$ million in October were $\$ 0.5$ million, or $0.2 \%$, below the official estimate. Fiscal year 2012-13 collections of $\$ 828.9$ million were $\$ 2.8$ million, or $0.3 \%$, above the official estimate.

The State Gaming Fund collected $\$ 71.1$ million in October. Fiscal year-to-date collections for the fund total \$285.8 million.
