GENERAL FUND

General Fund collections of \$4,270.9 million for the month of March were \$9.5 million, or 0.2%, below the official estimate. Fiscal year 2014-15 collections of \$21,711.2 million were above the official estimate by \$368.1 million, or 1.7%.

- Total Corporation Tax collections of \$2,369.7 million for the month of March were \$16.6 million, or 0.7%, above the official estimate. Year-to-date collections are \$186.2 million, or 4.9%, above estimate.
- Sales and Use Tax (SUT) collections of \$692.9 million were \$19.1 million, or 2.7%, below estimate. Year-to-date collections are \$42.6 million, or 0.6%, above estimate.
- Total Personal Income Tax (PIT) collections of \$972.8 million for the month of March were \$18.9 million, or 2.0%, above estimate. Year-to-date collections are \$36.7 million, or 0.5%, above the official estimate.
- Realty Transfer Tax (RTT) revenues of \$30.5 million were \$2.7 million, or 8.1%, below estimate. Year-to-date collections are \$26.2 million, or 8.0%, below estimate.
- Inheritance Tax revenues of \$78.7 million were \$17.5 million, or 18.2%, below estimate. Year-to-date collections are \$62.2 million, or 9.2%, above estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Table Games, and other miscellaneous tax collections totaled \$66.6 million for the month of March.
- Nontax revenue collections for the month of March were below the official estimate by \$14.2 million. Year-to-date collections are \$34.3 million above the official estimate.

MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of \$232.3 million in March were \$22.9 million, or 9.0%, below the official estimate. Fiscal year 2014-15 collections of \$1,901.0 million were \$98.5 million, or 5.5%, above the official estimate.

The State Gaming Fund collected \$76.7 million in March. Fiscal year-to-date collections for the fund total \$589.7 million.
