Due to certification of the 2015-16 revenue estimates in December 2015, the distributions for July-December 2015 closely match actual collections.

GENERAL FUND

General Fund collections for the month of September were \$2,733.0 million.

- Total Corporation Tax collections for September totaled \$517.9 million.
- Sales and Use Tax (SUT) collections for September totaled \$783.0 million.
- Total Personal Income Tax (PIT) collections for September totaled \$1,179.7 million.
- Realty Transfer Tax (RTT) revenues for September totaled \$36.2 million.
- Inheritance Tax revenues of for September totaled \$71.5 million.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Table Games, and other miscellaneous tax collections totaled \$121.5 million for the month of September.
- Nontax revenue collections for the month of September totaled \$23.0 million.
