Due to certification of the 2015-16 revenue estimates in December 2015, the distributions for July-December 2015 closely match actual collections.

GENERAL FUND

General Fund collections for the month of November were \$1,807.9 million.

- Total Corporation Tax collections for November totaled \$61.6 million.
- Sales and Use Tax (SUT) collections for November totaled \$761.3 million.
- Total Personal Income Tax (PIT) collections for November totaled \$765.2 million.
- Realty Transfer Tax (RTT) revenues for November totaled \$36.3 million.
- Inheritance Tax revenues of for November totaled \$65.7 million.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Table Games, and other miscellaneous tax collections totaled \$106.2 million for the month of November.
- Nontax revenue collections for the month of November totaled \$11.7 million.
