Due to certification of the 2015-16 revenue estimates in December 2015, the distributions for July-December 2015 closely match actual collections.

GENERAL FUND

General Fund collections for the month of December were \$2,725.0 million.

- Total Corporation Tax collections for December totaled \$528.6 million.
- Sales and Use Tax (SUT) collections for December totaled \$824.3 million.
- Total Personal Income Tax (PIT) collections for December totaled \$1,067.1 million.
- Realty Transfer Tax (RTT) revenues for December totaled \$33.1 million.
- Inheritance Tax revenues of for December totaled \$83.5 million.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Table Games, and other miscellaneous tax collections totaled \$159.2 million for the month of December.
- Nontax revenue collections for the month of December totaled \$29.2 million.
