GENERAL FUND

General Fund collections of \$4,486.0 million for the month of March were \$86.7 million, or 2.0%, above the official estimate. Fiscal year 2015-16 collections of \$22,240.2 million were above the official estimate by \$147.4 million, or 0.7%.

- Total Corporation Tax collections of \$2,357.6 million for the month of March were \$29.2 million, or 1.3%, above the official estimate. Year-to-date collections are \$72.4 million, or 1.8%, above estimate.
- Sales and Use Tax (SUT) collections of \$745.3 million were \$24.6 million, or 3.4%, above estimate. Year-to-date collections are \$27.8 million, or 0.4%, above estimate.
- Total Personal Income Tax (PIT) collections of \$1,107.9 million for the month of March were \$1.6 million, or 0.1%, below estimate. Year-to-date collections are \$21.5 million, or 0.2%, below the official estimate.
- Realty Transfer Tax (RTT) revenues of \$31.4 million were \$3.3 million, or 9.6%, below estimate. Year-to-date collections are \$5.4 million, or 1.5%, above estimate.
- Inheritance Tax revenues of \$97.5 million were \$11.6 million, or 13.5%, above estimate. Year-to-date collections are \$31.3 million, or 4.7%, above estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Table Games, and other miscellaneous tax collections totaled \$52.6 million for the month of March.
- Nontax revenue collections for the month of March were above the official estimate by \$25.5 million. Year-to-date collections are \$35.9 million above the official estimate.

MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of \$268.6 million in March were \$22.6 million, or 9.2%, above the official estimate. Fiscal year 2015-16 collections of \$1,938.1 million were \$10.8 million, or 0.6%, below the official estimate.

The State Gaming Fund collected \$68.7 million in March. Fiscal year-to-date collections for the fund total \$585.3 million.
