GENERAL FUND

General Fund collections of \$3,656.5 million for the month of April were \$24.8 million, or 0.7%, below the official estimate. Fiscal year 2015-16 collections of \$25,896.7 million were above the official estimate by \$122.6 million, or 0.5%.

- Total Corporation Tax collections of \$481.9 million for the month of April were \$33.3 million, or 7.4%, above the official estimate. Year-to-date collections are \$105.8 million, or 2.4%, above estimate.
- Sales and Use Tax (SUT) collections of \$842.2 million were \$21.5 million, or 2.5%, below estimate. Year-to-date collections are \$6.3 million, or 0.1%, above estimate.
- Total Personal Income Tax (PIT) collections of \$1,878.4 million for the month of April were \$85.0 million, or 4.3%, below estimate. Year-to-date collections are \$106.5 million, or 1.0%, below the official estimate.
- Realty Transfer Tax (RTT) revenues of \$32.8 million were \$3.8 million, or 10.5%, below estimate. Year-to-date collections are \$1.5 million, or 0.4%, above estimate.
- Inheritance Tax revenues of \$67.2 million were \$11.3 million, or 14.4%, below estimate. Year-to-date collections are \$20.0 million, or 2.7%, above estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Table Games, and other miscellaneous tax collections totaled \$119.1 million for the month of April.
- Nontax revenue collections for the month of April were above the official estimate by \$62.9 million. Year-to-date collections are \$98.8 million above the official estimate.

MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of \$220.4 million in April were \$27.2 million, or 11.0%, below the official estimate. Fiscal year 2015-16 collections of \$2,158.5 million were \$38.0 million, or 1.7%, below the official estimate.

The State Gaming Fund collected \$65.7 million in April. Fiscal year-to-date collections for the fund total \$651.0 million.
