GENERAL FUND

General Fund collections of \$1,987.1 million for the month of November were \$79.5 million, or 3.8%, below the official estimate. Fiscal year 2016-17 collections of \$10,836.4 million were below the official estimate by \$261.8 million, or 2.4%.

- Total Corporation Tax collections of \$31.9 million for the month of November were \$27.0 million, or 45.8%, below the official estimate. Year-to-date collections are \$57.0 million, or 6.6%, below estimate.
- Sales and Use Tax (SUT) collections of \$773.5 million were \$51.9 million, or 6.3%, below estimate. Year-to-date collections are \$122.2 million, or 2.9%, below estimate.
- Total Personal Income Tax (PIT) collections of \$865.9 million for the month of November were \$20.2 million, or 2.3%, below estimate. Year-to-date collections are \$81.1 million, or 1.8%, below the official estimate.
- Realty Transfer Tax (RTT) revenues of \$37.8 million were \$1.8 million, or 4.6%, below estimate. Year-to-date collections are \$28.0 million, or 12.3%, below estimate.
- Inheritance Tax revenues of \$68.5 million were \$5.0 million, or 6.8%, below estimate. Year-to-date collections are \$14.5 million, or 3.8%, below estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Table Games, and other miscellaneous tax collections totaled \$163.0 million for the month of November.
- Nontax revenue collections for the month of November were above the official estimate by \$49.5 million. Year-todate collections are \$49.1 million above the official estimate.

MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of \$222.6 million in November were \$3.1 million, or 1.4%, below the official estimate. Fiscal year 2016-17 collections of \$1,092.1 million were \$7.9 million, or 0.7%, below the official estimate.

The State Gaming Fund collected \$60.0 million in November. Fiscal year-to-date collections for the fund total \$330.3 million.
