#### **GENERAL FUND**

General Fund collections of \$2,618.4 million for the month of December were \$105.2 million, or 3.9%, below the official estimate. Fiscal year 2016-17 collections of \$13,454.8 million were below the official estimate by \$367.0 million, or 2.7%.

- Total Corporation Tax collections of \$466.7 million for the month of December were \$43.5 million, or 8.5%, below the official estimate. Year-to-date collections are \$100.5 million, or 7.3%, below estimate.
- Sales and Use Tax (SUT) collections of \$840.8 million were \$11.1 million, or 1.3%, below estimate. Year-to-date collections are \$133.3 million, or 2.6%, below estimate.
- Total Personal Income Tax (PIT) collections of \$962.4 million for the month of December were \$44.7 million, or 4.4%, below estimate. Year-to-date collections are \$125.9 million, or 2.3%, below the official estimate.
- Realty Transfer Tax (RTT) revenues of \$44.9 million were \$6.7 million, or 13.0%, below estimate. Year-to-date collections are \$34.7 million, or 12.4%, below estimate.
- Inheritance Tax revenues of \$84.5 million were \$3.7 million, or 4.6%, above estimate. Year-to-date collections are \$10.7 million, or 2.3%, below estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Table Games, and other miscellaneous tax collections totaled \$181.8 million for the month of December.
- Nontax revenue collections for the month of December were above the official estimate by \$5.2 million. Year-to-date collections are \$54.4 million above the official estimate.

### **MOTOR LICENSE AND GAMING FUNDS**

Motor License Fund collections of \$188.0 million in December were \$5.3 million, or 2.8%, below the official estimate. Fiscal year 2016-17 collections of \$1,280.2 million were \$13.2 million, or 1.0%, below the official estimate.

The State Gaming Fund collected \$54.3 million in December. Fiscal year-to-date collections for the fund total \$384.5 million.
