GENERAL FUND

General Fund collections of \$3,429.4 million for the month of April were \$537.1 million, or 13.5%, below the official estimate. Fiscal year 2016-17 collections of \$25,823.5 million were below the official estimate by \$1,216.4 million, or 4.5%.

- Total Corporation Tax collections of \$238.5 million for the month of April were \$227.4 million, or 48.8%, below the official estimate. Year-to-date collections are \$577.4 million, or 12.8%, below estimate.
- Sales and Use Tax (SUT) collections of \$831.0 million were \$58.3 million, or 6.6%, below estimate. Year-to-date collections are \$190.0 million, or 2.3%, below estimate.
- Total Personal Income Tax (PIT) collections of \$1,847.0 million for the month of April were \$181.5 million, or 8.9%, below estimate. Year-to-date collections are \$324.7 million, or 3.0%, below the official estimate.
- Realty Transfer Tax (RTT) revenues of \$34.1 million were \$9.7 million, or 22.0%, below estimate. Year-to-date collections are \$67.8 million, or 15.2%, below estimate.
- Inheritance Tax revenues of \$80.2 million were \$8.0 million, or 9.1%, below estimate. Year-to-date collections are \$22.6 million, or 2.9%, below estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Table Games, and other miscellaneous tax collections totaled \$183.5 million for the month of April.
- Nontax revenue collections for the month of April were below the official estimate by \$71.8 million. Year-to-date collections are \$44.5 million below the official estimate.

MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of \$278.8 million in April were \$19.6 million, or 7.6%, above the official estimate. Fiscal year 2016-17 collections of \$2,235.8 million were \$0.7 million, or 0.0%, below the official estimate.

The State Gaming Fund collected \$63.9 million in April. Fiscal year-to-date collections for the fund total \$646.5 million.

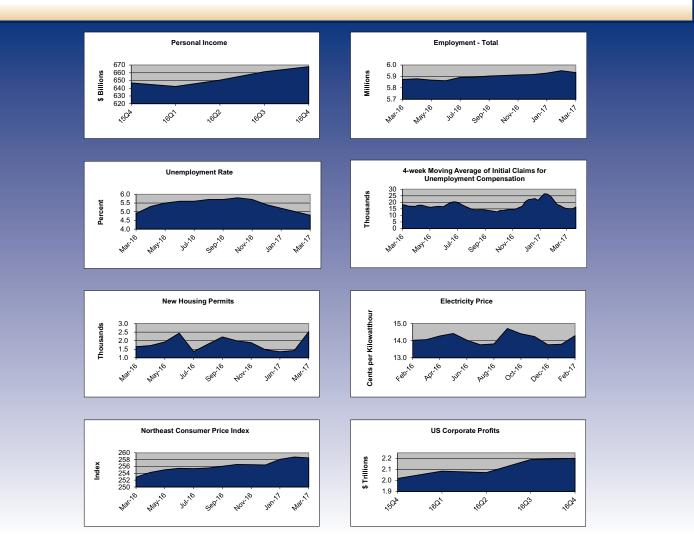
