GENERAL FUND

The June 2017 Monthly Revenue Report is being reissued due to a \$700,000 revision to Non-Motor Vehicle Sales & Use Tax posted in the Revenue and Receipts Report for the General Fund for May 2017. The Motor License Fund was not affected.

General Fund collections of \$3,264.3 million for the month of June were \$11.2 million, or 0.3%, above the official estimate. Fiscal year 2016-17 collections of \$31,669.0 million were below the official estimate by \$1,107.4 million, or 3.4%.

- Total Corporation Tax collections of \$648.7 million for the month of June were \$104.7 million, or 19.2%, above the official estimate. Year-to-date collections are \$340.3 million, or 6.6%, below estimate.
- Sales and Use Tax (SUT) collections of \$993.7 million were \$3.5 million, or 0.4%, below estimate. Year-to-date collections are \$200.0 million, or 2.0%, below estimate.
- Total Personal Income Tax (PIT) collections of \$1,220.7 million for the month of June were \$24.9 million, or 2.0%, below estimate. Year-to-date collections are \$387.6 million, or 3.0%, below the official estimate.
- Realty Transfer Tax (RTT) revenues of \$53.8 million were \$8.7 million, or 13.9%, below estimate. Year-to-date collections are \$76.5 million, or 13.8%, below estimate.
- Inheritance Tax revenues of \$122.7 million were \$2.8 million, or 2.3%, above estimate. Year-to-date collections are \$22.4 million, or 2.2%, below estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Table Games, and other miscellaneous tax collections totaled \$186.9 million for the month of June.
- Nontax revenue collections for the month of June were below the official estimate by \$63.1 million. Year-to-date collections are \$69.1 million below the official estimate.

MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of \$257.3 million in June were \$12.3 million, or 5.0%, above the official estimate. Fiscal year 2016-17 collections of \$2,758.5 million were \$7.5 million, or 0.3%, above the official estimate.

The State Gaming Fund collected \$62.0 million in June. Fiscal year-to-date collections for the fund total \$785.1 million.
