

Monthly Revenue Report October 2017



Due to recertification of the 2017-18 revenue estimates in November 2017, the distributions for July-October 2017 closely match actual collections.

GENERAL FUND

General Fund collections for the month of October were \$2,175.4 million.

- Total Corporation Tax collections for October totaled \$92.4 million. Year-to-date collections total \$709.6 million.
- Sales and Use Tax (SUT) collections for October totaled \$881.5 million. Year-to-date collections total \$3,472.7 million.
- Total Personal Income Tax (PIT) collections for October totaled \$906.7 million. Year-to-date collections total \$3,743.2 million.
- Realty Transfer Tax (RTT) revenues for October totaled \$46.2 million. Year-to-date collections total \$176.3 million.
- Inheritance Tax revenues for October totaled \$82.9 million. Year-to-date collections total \$316.6 million.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Gaming, and other miscellaneous tax collections totaled \$149.9 million for the month of October. Year-todate collections total \$612.6 million.
- Nontax revenue collections for the month of October totaled \$15.8 million. Year-to-date collections total \$77.5 million.


