GENERAL FUND

General Fund collections of \$3,581.4 million for the month of February were \$406.3 million, or 12.8%, above the official estimate. Fiscal year 2017-18 collections of \$20,949.2 million were above the official estimate by \$496.0 million, or 2.4%.

- Total Corporation Tax collections of \$77.0 million for the month of February were \$6.4 million, or 7.7%, below the official estimate. Year-to-date collections are \$30.5 million, or 2.0%, below estimate.
- Sales and Use Tax (SUT) collections of \$734.2 million were \$1.7 million, or 0.2%, above estimate. Year-to-date collections are \$4.3 million, or 0.1%, below estimate.
- Total Personal Income Tax (PIT) collections of \$857.2 million for the month of February were \$5.1 million, or 0.6%, above estimate. Year-to-date collections are \$138.2 million, or 1.7%, above the official estimate.
- Realty Transfer Tax (RTT) revenues of \$27.8 million were \$2.7 million, or 8.9%, below estimate. Year-to-date collections are \$1.5 million, or 0.5%, below estimate.
- Inheritance Tax revenues of \$71.2 million were \$7.5 million, or 11.8%, above estimate. Year-to-date collections are \$2.1 million, or 0.3%, below estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Gaming, and other miscellaneous tax collections totaled \$137.2 million for the month of February.
- Nontax revenue collections for the month of February were above the official estimate by \$398.8 million. Year-to-date collections are \$400.3 million above the official estimate.

MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of \$254.8 million in February were \$21.1 million, or 9.0%, above the official estimate. Fiscal year 2017-18 collections of \$1,948.3 million were \$53.3 million, or 2.8%, above the official estimate.

The State Gaming Fund collected \$63.9 million in February. Fiscal year-to-date collections for the fund total \$512.7 million.
