## GENERAL FUND

General Fund collections of $\$ 4,324.1$ million for the month of March were $\$ 274.2$ million, or $6.0 \%$, below the official estimate. Fiscal year 2017-18 collections of $\$ 25,273.2$ million were above the official estimate by \$221.7 million, or 0.9\%.

- Total Corporation Tax collections of $\$ 2,212.5$ million for the month of March were $\$ 121.4$ million, or $5.2 \%$, below the official estimate. Year-to-date collections are \$151.9 million, or 3.9\%, below estimate.
- Sales and Use Tax (SUT) collections of $\$ 787.1$ million were $\$ 9.0$ million, or $1.1 \%$, below estimate. Year-to-date collections are $\$ 13.4$ million, or $0.2 \%$, below estimate.
- Total Personal Income Tax (PIT) collections of $\$ 1,089.4$ million for the month of March were $\$ 23.1$ million, or $2.1 \%$, below estimate. Year-to-date collections are $\$ 115.1$ million, or $1.3 \%$, above the official estimate.
- Realty Transfer Tax (RTT) revenues of $\$ 40.3$ million were $\$ 5.7$ million, or $16.5 \%$, above estimate. Year-to-date collections are $\$ 4.2$ million, or $1.1 \%$, above estimate.
- Inheritance Tax revenues of $\$ 89.5$ million were $\$ 14.7$ million, or $14.1 \%$, below estimate. Year-to-date collections are $\$ 16.9$ million, or $2.3 \%$, below estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Gaming, and other miscellaneous tax collections totaled $\$ 70.2$ million for the month of March.
- Nontax revenue collections for the month of March were below the official estimate by $\$ 97.4$ million. Year-to-date collections are $\$ 302.8$ million above the official estimate.


## MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of $\$ 191.1$ million in March were $\$ 41.6$ million, or 17.9\%, below the official estimate. Fiscal year 2017-18 collections of $\$ \mathbf{2 , 1 3 9 . 4}$ million were $\$ 11.7$ million, or $0.5 \%$, above the official estimate.

The State Gaming Fund collected $\$ 68.2$ million in March. Fiscal year-to-date collections for the fund total $\$ 581.0$ million.
