## GENERAL FUND

General Fund collections of $\$ 3,753.9$ million for the month of April were $\$ 57.6$ million, or $1.5 \%$, below the official estimate. Fiscal year 2017-18 collections of $\$ 29,027.1$ million were above the official estimate by \$164.1 million, or 0.6\%.

- Total Corporation Tax collections of $\$ 313.2$ million for the month of April were $\$ 8.3$ million, or $2.7 \%$, above the official estimate. Year-to-date collections are $\$ 143.6$ million, or 3.4\%, below estimate.
- Sales and Use Tax (SUT) collections of $\$ 893.8$ million were $\$ 34.9$ million, or $4.1 \%$, above estimate. Year-to-date collections are $\$ 21.5$ million, or $0.3 \%$, above estimate.
- Total Personal Income Tax (PIT) collections of \$2,056.9 million for the month of April were $\$ 8.9$ million, or $0.4 \%$, above estimate. Year-to-date collections are $\$ 124.0$ million, or $1.1 \%$, above the official estimate.
- Realty Transfer Tax (RTT) revenues of $\$ 41.8$ million were $\$ 4.2$ million, or $11.2 \%$, above estimate. Year-to-date collections are $\$ 8.4$ million, or $2.1 \%$, above estimate.
- Inheritance Tax revenues of $\$ 100.1$ million were $\$ 13.8$ million, or $16.0 \%$, above estimate. Year-to-date collections are $\$ 3.0$ million, or $0.4 \%$, below estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Gaming, and other miscellaneous tax collections totaled $\$ 148.6$ million for the month of April.
- Nontax revenue collections for the month of April were below the official estimate by $\$ 90.9$ million. Year-to-date collections are $\$ 211.9$ million above the official estimate.


## MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of $\$ 307.0$ million in April were $\$ 56.7$ million, or $\mathbf{2 2 . 7} \%$, above the official estimate. Fiscal year 2017-18 collections of $\$ 2,446.4$ million were $\$ 68.4$ million, or $\mathbf{2 . 9} \%$, above the official estimate.

The State Gaming Fund collected $\$ 75.8$ million in April. Fiscal year-to-date collections for the fund total $\$ 656.8$ million.
