## GENERAL FUND

General Fund collections of $\$ 3,083.9$ million for the month of June were $\$ 258.7$ million, or $\mathbf{7 . 7 \%}$, below the official estimate. Fiscal year 2017-18 collections of $\$ 34,566.9$ million were below the official estimate by \$137.2 million, or 0.4\%.

- Total Corporation Tax collections of $\$ 568.1$ million for the month of June were $\$ 49.7$ million, or $8.1 \%$, below the official estimate. Year-to-date collections are $\$ 220.3$ million, or 4.3\%, below estimate.
- Sales and Use Tax (SUT) collections of $\$ 963.5$ million were $\$ 11.9$ million, or $1.3 \%$, above estimate. Year-to-date collections are $\$ 40.5$ million, or $0.4 \%$, above estimate.
- Total Personal Income Tax (PIT) collections of $\$ 1,139.9$ million for the month of June were $\$ 37.3$ million, or $3.2 \%$, below estimate. Year-to-date collections are $\$ 94.2$ million, or $0.7 \%$, above the official estimate.
- Realty Transfer Tax (RTT) revenues of $\$ 45.9$ million were $\$ 10.7$ million, or $18.9 \%$, below estimate. Year-to-date collections are $\$ 0.3$ million, or $0.1 \%$, above estimate.
- Inheritance Tax revenues of $\$ 91.8$ million were $\$ 10.2$ million, or $10.0 \%$, below estimate. Year-to-date collections are $\$ 2.3$ million, or $0.2 \%$, above estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Gaming, and other miscellaneous tax collections totaled $\$ 179.1$ million for the month of June.
- Nontax revenue collections for the month of June were below the official estimate by $\$ 155.6$ million. Year-to-date collections are $\$ 7.3$ million below the official estimate.


## MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of $\$ 247.9$ million in June were $\$ 3.6$ million, or $\mathbf{1 . 5 \%}$, above the official estimate. Fiscal year 2017-18 collections of $\$ 2,948.5$ million were $\$ 52.0$ million, or $1.8 \%$, above the official estimate.
The State Gaming Fund collected $\$ 61.0$ million in June. Fiscal year-to-date collections for the fund total $\$ \mathbf{7 8 6 . 9}$ million.
