GENERAL FUND

General Fund collections of \$3,041.2 million for the month of September were \$183.8 million, or 6.4%, above the official estimate. Fiscal year 2018-19 collections of \$7,553.8 million were above the official estimate by \$209.8 million, or 2.9%.

- Total Corporation Tax collections of \$647.0 million for the month of September were \$135.3 million, or 26.4%, above the official estimate. Year-to-date collections are \$169.3 million, or 25.6%, above estimate.
- Sales and Use Tax (SUT) collections of \$900.8 million were \$32.1 million, or 3.7%, above estimate. Year-to-date collections are \$67.7 million, or 2.5%, above estimate.
- Total Personal Income Tax (PIT) collections of \$1,181.0 million for the month of September were \$14.8 million, or 1.2%, below estimate. Year-to-date collections are \$35.4 million, or 1.2%, below the official estimate.
- Realty Transfer Tax (RTT) revenues of \$40.5 million were \$5.1 million, or 11.2%, below estimate. Year-to-date collections are \$4.2 million, or 3.1%, below estimate.
- Inheritance Tax revenues of \$82.5 million were \$6.5 million, or 8.5%, above estimate. Year-to-date collections are \$6.0 million, or 2.4%, above estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Gaming, and other miscellaneous tax collections totaled \$153.9 million for the month of September.
- Nontax revenue collections for the month of September were above the official estimate by \$42.0 million. Year-todate collections are \$8.5 million above the official estimate.

MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of \$228.5 million in September were \$1.1 million, or 0.5%, above the official estimate. Fiscal year 2018-19 collections of \$710.8 million were \$12.1 million, or 1.7%, below the official estimate.

The State Gaming Fund collected \$58.3 million in September. Fiscal year-to-date collections for the fund total \$199.7 million.
