## GENERAL FUND

General Fund collections of $\$ 2,474.5$ million for the month of October were $\$ 28.3$ million, or $\mathbf{1 . 2 \%}$, above the official estimate. Fiscal year 2018-19 collections of $\$ 10,028.2$ million were above the official estimate by \$238.0 million, or 2.4\%.

- Total Corporation Tax collections of $\$ 111.2$ million for the month of October were $\$ 10.5$ million, or $10.4 \%$, above the official estimate. Year-to-date collections are \$179.8 million, or $23.6 \%$, above estimate.
- Sales and Use Tax (SUT) collections of $\$ 959.4$ million were $\$ 26.8$ million, or $2.9 \%$, above estimate. Year-to-date collections are $\$ 94.5$ million, or $2.6 \%$, above estimate.
- Total Personal Income Tax (PIT) collections of $\$ 1,088.3$ million for the month of October were $\$ 5.4$ million, or $0.5 \%$, below estimate. Year-to-date collections are $\$ 40.8$ million, or $1.0 \%$, below the official estimate.
- Realty Transfer Tax (RTT) revenues of $\$ 51.0$ million were $\$ 0.2$ million, or $0.3 \%$, above estimate. Year-to-date collections are $\$ 4.0$ million, or $2.1 \%$, below estimate.
- Inheritance Tax revenues of $\$ 90.3$ million were $\$ 3.1$ million, or $3.6 \%$, above estimate. Year-to-date collections are $\$ 9.1$ million, or $2.7 \%$, above estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Gaming, and other miscellaneous tax collections totaled $\$ 144.5$ million for the month of October.
- Nontax revenue collections for the month of October were above the official estimate by $\$ 11.4$ million. Year-to-date collections are $\$ 19.9$ million above the official estimate.


## MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of $\$ 205.0$ million in October were $\$ 23.8$ million, or $\mathbf{1 0 . 4} \%$, below the official estimate. Fiscal year 2018-19 collections of $\$ 915.8$ million were $\$ 35.9$ million, or 3.8\%, below the official estimate.
The State Gaming Fund collected $\$ 70.2$ million in October. Fiscal year-to-date collections for the fund total $\mathbf{\$ 2 7 0 . 0}$ million.
