

Monthly Revenue Report April 2020

Commonwealth of Pennsylvania Department of Revenue

General Fund

General Fund collections of \$2.2 billion for the month of April were \$2.2 billion, or 49.7 percent, below the official estimate. Fiscal year 2019-20 collections of \$27.5 billion were \$2.2 billion, or 7.4 percent, below estimate.

- Total Corporation Tax collections of \$176.3 million for the month of April were \$149.5 million below the official estimate. Year-to-date collections are \$396.3 million, or 8.4 percent, below estimate.
- Sales and Use Tax (SUT) collections of \$636.7 million were \$361.4 million below estimate. Year-to-date collections are \$293.2 million, or 3.1 percent, below estimate.
- Total Personal Income Tax (PIT) collections of \$1.1 billion for the month of April were \$1.5 billion below estimate. Year-to-date collections are \$1.5 billion, or 12.4 percent, below the official estimate.
- Realty Transfer Tax (RTT) revenues of \$26.6 million were \$23.0 million below estimate. Year-todate collections are \$13.4 million, or 3.0 percent, below estimate.
- Inheritance Tax revenues of \$65.4 million were \$36.1 million below estimate. Year-to-date collections are \$29.7 million, or 3.3 percent, above estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Gaming, and other miscellaneous tax collections totaled (\$11.4) million for the month of April.
- Nontax revenue collections for the month of April were \$22.0 million below estimate. Year-todate collections are \$42.6 million, or 8.0 percent, above the official estimate.

Motor License and Gaming Funds

Motor License Fund collections of \$173.1 million in April were \$99.6 million below the official estimate. Fiscal year 2019-20 collections of \$2.2 billion were \$120.9 million, or 5.2 percent, below the official estimate.

The State Gaming Fund collected \$7.3 million in April. Fiscal year-to-date collections for the fund total \$582.7 million.


