GENERAL FUND

General Fund collections of \$2.5 billion for the month of August were \$209.0 million, or 8.9 percent, above the official estimate. Fiscal year 2020-21 collections of \$6.7 billion were \$210.3 million, or 3.3 percent, above estimate.

- Total Corporation Tax collections of \$303.3 million for the month of August were \$26.8 million above the official estimate. Year-to-date collections are \$28.2 million, or 5.5 percent, above estimate.
- Sales and Use Tax (SUT) collections of \$1.0 billion were \$92.7 million above estimate. Year-to-date collections are \$92.7 million, or 4.2 percent, above estimate.
- Total Personal Income Tax (PIT) collections of \$876.1 million for the month of August were \$42.9 million above estimate.
 Year-to-date collections are \$42.9 million, or 1.4 percent, above the official estimate.
- Realty Transfer Tax (RTT) revenues of \$56.5 million were \$14.3 million above estimate. Year-to-date collections are \$14.3 million, or 23.8 percent, above estimate.
- Inheritance Tax revenues of \$92.1 million were \$5.9 million above estimate. Year-to-date collections are \$5.8 million, or 2.9 percent, above estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Gaming, and other miscellaneous tax collections totaled \$169.4 million for the month of August.
- Nontax revenue collections for the month of August were \$5.6 million below estimate. Year-to-date collections are \$5.5 million, or 13.7 percent, below the official estimate.

MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of \$265.8 million in August were \$0.9 million below the official estimate. Fiscal year 2020-21 collections of \$553.2 million were \$6.4 million, or 1.2 percent, above the official estimate.

The State Gaming Fund collected \$72.0 million in August. Fiscal year-to-date collections for the fund total \$139.3 million.
