## GENERAL FUND

General Fund collections of \$2.6 billion for the month of October were $\$ 365.6$ million, or 16.4 percent, above the official estimate. Fiscal year 2020-21 collections of $\$ 12.5$ billion were $\$ 824.5$ million, or 7.1 percent, above estimate.

- Total Corporation Tax collections of $\$ 122.6$ million for the month of October were $\$ 25.2$ million above the official estimate. Year-to-date collections are $\$ 157.8$ million, or 14.3 percent, above estimate.
- Sales and Use Tax (SUT) collections of $\$ 1.1$ billion were $\$ 145.0$ million above estimate. Year-to-date collections are $\$ 328.4$ million, or 8.1 percent, above estimate.
- Total Personal Income Tax (PIT) collections of $\$ 1.0$ billion for the month of October were $\$ 123.2$ million above estimate. Year-to-date collections are $\$ 185.6$ million, or 3.5 percent, above the official estimate.
- Realty Transfer Tax (RTT) revenues of $\$ 65.4$ million were $\$ 22.2$ million above estimate. Year-to-date collections are $\$ 55.3$ million, or 40.1 percent, above estimate.
- Inheritance Tax revenues of $\$ 97.1$ million were $\$ 17.0$ million above estimate. Year-to-date collections are \$51.3 million, or 14.5 percent, above estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Gaming, and other miscellaneous tax collections totaled $\$ 161.1$ million for the month of October.
- Nontax revenue collections for the month of October were $\$ 8.7$ million above estimate. Year-to-date collections are $\$ 31.8$ million, or 26.8 percent, below the official estimate.


## MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of $\$ 205.3$ million in October were $\$ 6.3$ million below the official estimate. Fiscal year 2020-21 collections of $\$ 975.3$ million were $\$ 6.1$ million, or 0.6 percent, below the official estimate.

The State Gaming Fund collected $\$ 62.7$ million in October. Fiscal year-to-date collections for the fund total \$267.3 million.
