## GENERAL FUND

General Fund collections of $\$ 3.9$ billion for the month of May were $\$ 1.6$ billion, or 65.4 percent, above the official estimate. Fiscal year 2020-21 collections of $\$ 36.6$ billion were $\$ 2.9$ billion, or 8.5 percent, above estimate.

- Total Corporation Tax collections of $\$ 430.1$ million for the month of May were $\$ 163.7$ million above the official estimate. Year-to-date collections are $\$ 892.2$ million, or 18.9 percent, above estimate.
- Sales and Use Tax (SUT) collections of $\$ 1.2$ billion were $\$ 211.8$ million above estimate. Year-to-date collections are $\$ 741.7$ million, or 6.8 percent, above estimate.
- Total Personal Income Tax (PIT) collections of $\$ 1.9$ billion for the month of May were $\$ 1.0$ billion above estimate. Year-to-date collections are $\$ 747.7$ million, or 5.3 percent, above the official estimate.
- Realty Transfer Tax (RTT) revenues of $\$ 56.9$ million were $\$ 14.8$ million above estimate. Year-to-date collections are $\$ 95.5$ million, or 19.9 percent, above estimate.
- Inheritance Tax revenues of $\$ 136.0$ million were $\$ 53.5$ million above estimate. Year-to-date collections are $\$ 216.5$ million, or 21.1 percent, above estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Gaming, and other miscellaneous tax collections totaled $\$ 191.0$ million for the month of May.
- Nontax revenue collections for the month of May were $\$ 45.6$ million above estimate. Year-to-date collections are $\$ 42.8$ million, or 4.0 percent, above the official estimate.

## MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of $\$ 236.2$ million in May were $\$ 3.1$ million below the official estimate. Fiscal year 2020-21 collections of $\$ 2.6$ billion were $\$ 17.6$ million, or 0.7 percent, below the official estimate.

The State Gaming Fund collected $\$ 79.5$ million in May. Fiscal year-to-date collections for the fund total $\$ 741.8$ million.
