GENERAL FUND

General Fund Collections of \$2.6 billion for the month of August were \$135.5 million, or 5.6 percent, above the official estimate. Fiscal year 2021-22 collections of \$5.3 billion were \$132.4 million, or 2.6 percent, above estimate.

• Total Corporation Tax collections of \$112.1 million for the month of August were \$27.0 million above the official estimate. Year-to-date collections are \$23.7 million, or 8.5 percent, above estimate.

• Sales and Use Tax (SUT) collections of \$1.1 billion were \$49.3 million above estimate. Year-to-date collections are \$49.3 million, or 2.1 percent, above estimate.

• Total Personal Income Tax (PIT) collections of \$978.8 million for the month of August were \$67.1 million above estimate. Year-to-date collections are \$67.2 million, or 3.6 percent, above the official estimate.

• Realty Transfer Tax (RTT) revenues of \$72.3 million were \$1.6 million above estimate. Year-to-date collections are \$1.5 million, or 1.5 percent, above estimate.

• Inheritance Tax revenues of \$110.0 million were \$12.5 million below estimate. Year-to-date collections are \$12.6 million, or 5.3 percent, below estimate.

• Other tax revenue including Cigarette, Malt Beverage, Liquor, Gaming, and other miscellaneous tax collections totaled \$173.0 million for the month of August.

• Nontax revenue collections for the month of August were \$0.7 million above estimate. Year-to-date collections are \$0.8 million, or 1.7 percent, above the official estimate.

Motor License Fund collections of \$258.5 million in August were \$0.1 million above the official estimate. Fiscal year 2021-22 collections of \$493.0 million were \$2.4 million, or 0.5 percent, above the official estimate.

The State Gaming Fund collected \$101.9 million in August. Fiscal year-to-date collections for the fund total \$192.7 million.





2021-22 GENERAL FUND REVENUES




