SEPTEMBER 2021

GENERAL FUND

General Fund Collections of \$4.0 billion for the month of September were \$495.9 million, or 14.1 percent, above the official estimate. Fiscal year 2021-22 collections of \$9.3 billion were \$628.3 million, or 7.3 percent, above estimate.

- Total Corporation Tax collections of \$898.2 million for the month of September were \$233.7 million above the official estimate. Year-to-date collections are \$257.4 million, or 27.3 percent, above estimate.
- Sales and Use Tax (SUT) collections of \$1.1 billion were \$93.0 million above estimate. Year-to-date collections are \$142.3 million, or 4.3 percent, above estimate.
- Total Personal Income Tax (PIT) collections of \$1.5 billion for the month of September were \$97.8 million above estimate. Year-to-date collections are \$164.9 million, or 5.0 percent, above the official estimate.
- Realty Transfer Tax (RTT) revenues of \$75.6 million were \$14.8 million above estimate. Year-to-date collections are \$16.3 million, or 9.8 percent, above estimate.
- Inheritance Tax revenues of \$143.4 million were \$25.4 million above estimate. Year-to-date collections are \$12.8 million, or 3.6 percent, above estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Gaming, and other miscellaneous tax collections totaled \$183.5 million for the month of September.
- Nontax revenue collections for the month of September were \$17.5 million above estimate. Year-to-date collections are \$18.3 million, or 27.2 percent, above the official estimate.

MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of \$236.8 million in September were \$20.0 million above the official estimate. Fiscal year 2021-22 collections of \$729.8 million were \$22.5 million, or 3.2 percent, above the official estimate.

The State Gaming Fund collected \$87.0 million in September. Fiscal year-to-date collections for the fund total \$279.7 million.





2021-22 GENERAL FUND REVENUES







