GENERAL FUND

General Fund Collections of \$5.6 billion for the month of March were \$659.1 million, or 13.5 percent, above the official estimate. Fiscal year 2021-22 collections of \$34.1 billion were \$2.7 billion, or 8.5 percent, above estimate.

• Total Corporation Tax collections of \$2.4 billion for the month of March were \$188.0 million above the official estimate. Year-to-date collections are \$810.6 million, or 18.6 percent, above estimate.

• Sales and Use Tax (SUT) collections of \$1.1 billion were \$208.1 million above estimate. Year-to-date collections are \$767.7 million, or 8.1 percent, above estimate.

• Total Personal Income Tax (PIT) collections of \$1.6 billion for the month of March were \$158.6 million above estimate. Year-to-date collections are \$687.6 million, or 6.5 percent, above the official estimate.

• Realty Transfer Tax (RTT) revenues of \$74.8 million were \$21.8 million above estimate. Year-to-date collections are \$114.2 million, or 22.4 percent, above estimate.

• Inheritance Tax revenues of \$158.8 million were \$31.4 million above estimate. Year-to-date collections are \$122.2 million, or 11.7 percent, above estimate.

• Other tax revenue including Cigarette, Malt Beverage, Liquor, Gaming, and other miscellaneous tax collections totaled \$67.7 million for the month of March.

• Nontax revenue collections for the month of March were \$42.0 million above estimate. Year-to-date collections are \$126.3 million, or 3.0 percent, above the official estimate.

MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of \$239.7 million in March were \$19.4 million above the official estimate. Fiscal year 2021-22 collections of \$2.1 billion were \$55.6 million, or 2.7 percent, above the official estimate.

The State Gaming Fund collected \$95.6 million in March. Fiscal year-to-date collections for the fund total \$813.9 million.






