GENERAL FUND

General Fund Collections of \$4.2 billion for the month of June were \$713.7 million, or 20.2 percent, above the official estimate. Fiscal year 2021-22 collections of \$48.1 billion were \$5.6 billion, or 13.2 percent, above estimate.

- Total Corporation Tax collections of \$972.0 million for the month of June were \$406.0 million above the official estimate. Year-to-date collections are \$1.7 billion, or 29.2 percent, above estimate.
- Sales and Use Tax (SUT) collections of \$1.2 billion were \$95.6 million above estimate. Year-to-date collections are \$1.1 billion, or 8.7 percent, above estimate.
- Total Personal Income Tax (PIT) collections of \$1.6 billion for the month of June were \$179.8 million above estimate. Year-to-date collections are \$2.4 billion, or 14.9 percent, above the official estimate.
- Realty Transfer Tax (RTT) revenues of \$76.0 million were \$10.3 million above estimate. Year-to-date collections are \$164.2 million, or 24.0 percent, above estimate.
- Inheritance Tax revenues of \$121.6 million were \$13.2 million above estimate. Year-to-date collections are \$173.0 million, or 12.6 percent, above estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Gaming, and other miscellaneous tax collections totaled \$178.4 million for the month of June.
- Nontax revenue collections for the month of June were \$4.3 million above estimate. Year-to-date collections are \$117.2 million, or 2.6 percent, above the official estimate.

MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of \$253.2 million in June were \$7.1 million above the official estimate. Fiscal year 2021-22 collections of \$2.9 billion were \$37.4 million, or 1.3 percent, above the official estimate.

The State Gaming Fund collected \$86.9 million in June. Fiscal year-to-date collections for the fund total \$1.1 billion.

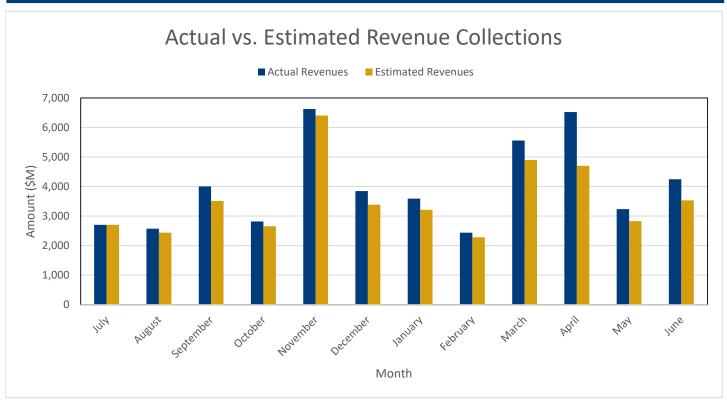

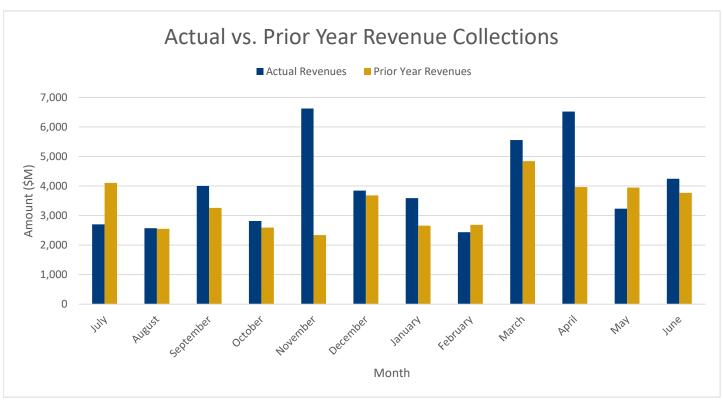

2021-22 GENERAL FUND REVENUES



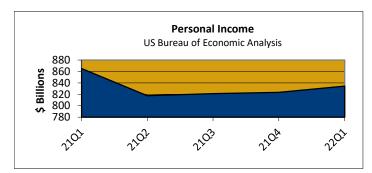


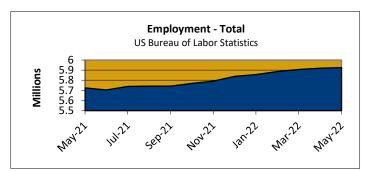
