# COMPUTER DATA CENTER EQUIPMENT EXEMPTION PROGRAM

#### CERTIFICATION YEAR 2023

Pursuant to § 1707-A.1. of the Tax Reform Code of 1971, the Department of Revenue is required to furnish a report for each tax credit or benefit it administers, reporting the name of each applicant that receives a tax credit or benefit. Details regarding the Computer Data Center Equipment Exemption Program certifications in 2023 may be found below.

#### **DESCRIPTION OF TAX BENEFIT**

The Computer Data Center Equipment Exemption Program was created under Act 25-2021 and replaced a capped refund program. Beginning January 1, 2022, computer data center equipment is exempt from Pennsylvania sales and use tax when it is sold to, used, or consumed in a certified data center, by an owner, operator, or qualified tenant holding a Computer Data Center Sales and Use Tax Certificate of Exemption. In order to qualify, the entity must affirm it will meet the requirements for eligibility on or before the fourth anniversary of certification. Certification is valid for a period of 25 full calendar years following the year in which the owner or operator filed the application for certification. Requirement are as follows:

1. Create a minimum new investment of:

At least \$75M, on or after January 1, 2022, if the computer data center is located in a county with a population of 250,000 or fewer individuals, and create 25 new jobs;

Or, at least \$100M, on or after January 1, 2022, if the computer data center is located in a county with a population of more than 250,000 individuals, and create 45 new jobs.

2. Pay annual compensation in the aggregate of at least \$1,000,000 to employees at the certified computer data center site for each year of the certification after the fourth anniversary of certification.

If the applicant fails to meet the requirements set forth above, the Department may revoke the certification and recapture all or part of the tax benefits provided to the owner, operator, or qualified tenants during the qualification period.
