e-file Signature Authorization for RCT-101, PA Corporate Net Income Tax Report

PA-8879 C IN (SU) 11-21

PURPOSE OF FORM

A corporate officer and an electronic return originator (ERO) use the PA-8879 C when the corporate officer wants to use a federal self-select PIN to electronically sign a corporation's electronic tax report and, if applicable, consent to electronic funds withdrawal. A corporate officer who does not use the PA-8879 C must use the PA-8453 C, PA Corporate Net Income Tax Declaration for a State e-file Report. You do not need to complete and retain both forms. For more information, see the instructions for the PA-8453 C.

Do not send this form to the PA Department of Revenue unless requested. The ERO must retain Form PA-8879 C.

ERO's RESPONSIBILITIES

The ERO must:

- Enter the name, Federal Employer Identification Number, address and Revenue ID Number of the corporation at the top of the form.
- · Complete Section I using the amounts from the corporation's 2021 tax report (zeros may be entered when appropriate).
- · Enter on the authorization line in Section II, the ERO firm name (not the name of the individual preparing the report) if the ERO is authorized to enter the officer's federal self-select PIN.
- Give the officer Form PA-8879 C for completion and review.
- Complete Section III, including signature and date.

NOTE: The ERO must receive the completed and signed PA-8879 C from the officer before the electronic report is transmitted or released for transmission.

OFFICER RESPONSIBILITIES

The corporate officer must:

- · Verify the accuracy of the corporation's prepared tax report.
- Check the appropriate box in Section II to authorize the ERO to enter the officer's federal self-select PIN or to choose to enter it in person.
- · Indicate or verify the officer's federal self-select PIN when authorizing the ERO to enter it (the PIN must be five numbers other than all zeros).
- · Complete, sign, date and enter the officer's title in Section II.
- Return the completed PA-8879 C to the ERO.

IMPORTANT NOTES FOR ERO's

- Do not send Form PA-8879 C to the PA Department of Revenue unless requested to do so. Retain the completed PA-8879 C for three years from the report due date or the date the report was filed electronically, whichever is later.
- · Enter the corporate officer's federal self-select PIN on the input screen only when authorized to do so by the corporate officer.
- Provide the officer with a copy of the signed PA-8879 C upon request.
- Provide the officer with a corrected copy of the PA-8879 C if changes are made to the report.
- The corporation's report will not be transmitted to the PA Department of Revenue until the ERO receives the officer's completed and signed PA-8879 C.

I consent to allow my electronic return originator (ERO) or transmitter to send the corporation's return/report to the Internal Revenue Service (IRS) and subsequently by the IRS to the PA Department of Revenue.

ELECTRONIC FUNDS WITHDRAWAL CONSENT

I authorize the PA Department of Revenue and its designated financial institution to initiate an electronic funds withdrawal entry to my financial institution account designated in the electronic payment portion of my 2021 RCT-101 for payment of my Pennsylvania taxes owed; and my financial institution to debit the entry to my account. I also authorize the financial institutions involved in the processing of my electronic payment of taxes to receive confidential information necessary to answer inquiries and resolve issues related to my payment. To revoke a payment, I must contact my financial institution account indicated in the tax preparation software for payment of the corporation state taxes.
