The following credits are reported on PA Schedule OC: PA Employment Incentive Payments Credit; PA Job Creation Tax Credit; PA Research and Development Tax Credit; PA Film Production Tax Credit; PA Organ and Bone Marrow Donor Tax Credit; PA Keystone Innovation Zone Tax Credit; PA Resource Enhancement and Protection Tax Credit; PA Neighborhood Assistance Program Tax Credit; PA Strategic Development Area Job Creation Tax Credit; PA Educational Improvement Tax Credit; and PA Volunteer Responder Retention and Recruitment Tax Credit. Submit the required supporting document for each credit you are claiming.

If you are a shareholder of a PA S corporation or a partner in a partnership, enter your share of each credit from your PA Schedule RK-1 or PA Schedule NRK-1. In the box to the left of the credit line, enter the Credit Description Code that applies to the credit you are claiming. 8. PA Neighborhood Assistance Program Tax Credit

Enter the amount from the PA Department of Community and Economic Development certification you received.

9. PA Strategic Development Area Job Creation Tax Credit

Enter the amount from the PA Department of Community and Economic Development certification you received.

10. PA Educational Improvement Tax Credit

Enter the amount from the PA Department of Community and Economic Development certification you received.

11. PA Volunteer Responder Retention and Recruitment Tax Credit
