PA-41 Payment Voucher (PA-V)

Use the 2012 form PA-V with your payment if you owe tax with your 2012 PA-41, Fiduciary Income Tax Return. Do not use this voucher for any other purpose. Follow the instructions below.

Federal Employer Identification Number (FEIN)/ Social Security Number (SSN)

- FEIN enter the fiduciary's (estate or trust) nine-digit FEIN with a hyphen followed by "F."
- SSN If the estate has not received its FEIN from the IRS, enter SS followed by the decedent's nine-digit Social Security number with the hyphens.
- NO FEIN if the trust has not yet received its FEIN from the IRS, write "APPLIEDFR" in the space provided for the FEIN.

Check Digit

Print the first two letters of the last name of the fiduciary (estate or trust).

Name and Title of Fiduciary

• Lines 1 through 4 - print the last name, first name and middle initial of the fiduciary (estate or trust).

Example:

- Estate SMITH JOHN T ESTATE OF
- Trust JONES MARY S TRUST

Address of Fiduciary

- Lines 5 and 6 Print the fiduciary's (estate or trust) complete street address. If the address has an apartment, suite or RR number, enter after the street address.
- Line 7 Print the name of the city. For foreign addresses, the bottom line of the address should show only the country name, written in full (no abbreviations) and in capital letters.
- Line 8 Print the two-digit state abbreviation.
- Line 9 Print the five-digit ZIP Code.

Fiduciary Phone Number

Print the fiduciary's (estate or trust) 10-digit phone number with area code including hyphens.

Pavment

Carefully enter the amount of your payment.

Make the check or money order payable to the PA DEPT. OF REVENUE. Please write on your check or money order:

- the estate's or trust's FEIN (including "F");
- "2012 PA-41"; and
- daytime telephone number of the estate's or trust's representative.

The department will need your FEIN if your check becomes separated from your PA-V. The department will need your FEIN to accurately apply your payment.
