

**PA-41 Payment Voucher (PA-V)**

Use the 2014 form PA-V with your payment if you owe tax with your 2014 PA-41, Fiduciary Income Tax Return. Do not use this voucher for any other purpose. Follow the instructions below.

**Federal Employer Identification Number (FEIN)/ Social Security Number (SSN)**

- FEIN - enter the fiduciary's (estate or trust) nine-digit FEIN without a hyphen followed by "F."
- SSN - If the estate has not received its FEIN from the IRS, enter SS followed by the first seven digits of the decedent's Social Security number without the hyphens followed by "F".
- NO FEIN - if the trust has not yet received its FEIN from the IRS, write "APPLIEDFR" in the space provided for the FEIN.

**Check Digit**

Print the first two letters of the last name of the fiduciary (estate or trust).

**Name and Title of Fiduciary**

- Print the last name, first name and middle initial of the fiduciary (estate or trust).

**Example:**

- Estate - SMITH JOHN T ESTATE OF
- Trust - JONES MARY S TRUST

**Address of Fiduciary**

- First and Second Line of Address - Print the fiduciary's (estate or trust) complete street address. If the address has an apartment, suite or RR number, enter after the street address.
- City - Print the name of the city. For foreign addresses, the bottom line of the address should show only the country name, written in full (no abbreviations) and in capital letters.
- State - Print the two-digit state abbreviation.
- ZIP - Print the five-digit ZIP Code.

**Fiduciary Phone Number**

Print the fiduciary's (estate or trust) 10-digit phone number with area code including hyphens.

**Payment**

Carefully enter the amount of your payment.

Make the check or money order payable to the PA DEPT. OF REVENUE. Please write on your check or money order:

- the estate's or trust's FEIN (including "F");
- "2014 PA-41"; and
- daytime telephone number of the estate's or trust's representative.

The department will need your FEIN if your check becomes separated from your PA-V. The department will need your FEIN to accurately apply your payment.
