CAUTION: If Line 33 is less than \$246, the estate or trust may still be subject to estimated underpayment penalties if the estate or trust's actual tax liability for 2021 after payments and credits is more than \$246. If the estate or trust has unexpected income or income grows to an amount in excess of \$8,000 with no payments or credits being scheduled for the tax year, the estate or trust should immediately file an amended declaration and make estimated tax payments accordingly.

NOTE. The department will apply the credit from the 2020 PA-41 form as of the due date of the 2020 PA-41 form. If the 2020 credit is greater than the first 2021 installment payment, it is not necessary to file the first estimated form. The department does not require a 2021 estimated form until you must make a PA PIT estimated installment payment on behalf of the estate or trust.
