

Monthly Revenue Report June 2001

General Fund

General Fund collections of \$1,849.8 million in June fell short of the monthly estimate by \$89.8 million, or 4.6%. Fiscal year 2000-01 collections of \$20,561.7 million exceeded estimate by \$81.2 million, or 0.4%.

- Total Corporation Taxes for the month were below estimate by \$88.1 million due largely to lower than anticipated 2001 Corporate Net Income Tax estimated quarterly payments. Fiscal year 2000-01 Corporation Tax collections of \$3,863.6 million fell short of the official estimate by 0.7%.
- Sales and Use Tax (SUT) revenues for 2000-01 totaled \$7,203.8 million, which was 1.2% below estimate. Total 2000-01 SUT collections were 2.6% above the previous fiscal year with non-motor vehicle and motor vehicle receipts growing at 2.6% and 2.9%, respectively.
- Personal Income Tax (PIT) collections of \$7,491.5 million for the fiscal year exceeded the official estimate by 1.8%. Total PIT collections for the 2000-01 fiscal year were 6.0% above the prior year.
- Realty Transfer Tax (RTT) collections of \$268.8 million for the fiscal year fell short of the official estimate by \$7.3 million, or 2.6%. Compared to collections of the prior fiscal year, RTT collections were down 1.1%.
- Inheritance Tax collections of \$799.8 million for the fiscal year fell short of the official estimate by \$1.5 million, or 0.2%.
- Total Nontax revenue collections of \$470.7 million for the fiscal year exceeded the official estimate by 15.0%. Miscellaneous revenues were substantially below estimate for June in large part because of the recording of the investment returns for the initial six months from a long-term investment strategy implemented by the Treasury Department in December 2000.

Motor License Fund

Motor License Fund collections of \$101.7 million in June were \$20.7 million below estimate. Fiscal year 2000-01 collections of \$1,951.8 million were \$18.6 million, or 0.9%, below estimate.

• Liquid Fuels Tax collections of \$1,070.2 million for the fiscal year were \$12.0 million, or 1.1%, above the official estimate. Total Liquid Fuel collections grew at a rate of 1.5% compared to the prior year.





Comparison of Cumulative Tax Refunds










Monthly Revenue Receipts

Cumulative Differences from Official Estimate and Prior Year Collections













Motor License Fund Cumulative Differences from Official Estimate and Prior Year Collections
