GENERAL FUND

General Fund collections of \$2,085.7 million for the month of October were \$29.0 million, or 1.4%, above the official estimate. Fiscal year 2013-14 collections of \$8,195.2 million were above the official estimate by \$41.8 million, or 0.5%.

- Total Corporation Tax collections of \$159.9 million for the month of October were \$20.2 million, or 14.4%, above the official estimate. Year-to-date collections are \$10.2 million, or 1.4%, above estimate.
- Sales and Use Tax (SUT) collections of \$783.1 million were \$5.3 million, or 0.7%, above estimate. Year-to-date collections are \$25.9 million, or 0.8%, above estimate.
- Total Personal Income Tax (PIT) collections of \$896.2 million for the month of October were \$2.4 million, or 0.3%, above estimate. Year-to-date collections are \$5.3 million, or 0.2%, above the official estimate.
- Realty Transfer Tax (RTT) revenues of \$33.5 million were \$3.6 million, or 9.7%, below estimate. Year-to-date collections are \$2.6 million, or 1.8%, above estimate.
- Inheritance Tax revenues of \$73.5 million were \$0.1 million, or 0.1%, below estimate. Year-to-date collections are \$0.3 million, or 0.1%, below estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Table Games, and other miscellaneous tax collections totaled \$119.9 million for the month of October.
- Nontax revenue collections for the month of October were above the official estimate by \$6.6 million. Year-to-date collections are \$2.2 million above the official estimate.



MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of \$214.7 million in October were \$2.0 million, or 0.9%, above the official estimate. Fiscal year 2013-14 collections of \$817.7 million were \$14.5 million, or 1.7%, below the official estimate.

The State Gaming Fund collected \$64.0 million in October. Fiscal year-to-date collections for the fund total \$274.8 million.

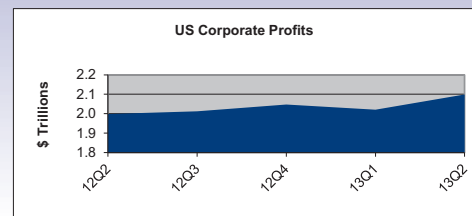
