GENERAL FUND

The May 2017 Monthly Revenue Report is being reissued due to a \$700,000 revision to Non-Motor Vehicle Sales & Use Tax posted in the Revenue and Receipts Report for the General Fund. The Motor License Fund was not affected.

General Fund collections of \$2,581.2 million for the month of May were \$97.8 million, or 3.9%, above the official estimate. Fiscal year 2016-17 collections of \$28,404.7 million were below the official estimate by \$1,118.6 million, or 3.8%.

- Total Corporation Tax collections of \$230.5 million for the month of May were \$132.4 million, or 135.0%, above the official estimate. Year-to-date collections are \$445.0 million, or 9.7%, below estimate.
- Sales and Use Tax (SUT) collections of \$823.0 million were \$6.5 million, or 0.8%, below estimate. Year-to-date collections are \$196.5 million, or 2.1%, below estimate.
- Total Personal Income Tax (PIT) collections of \$911.8 million for the month of May were \$38.0 million, or 4.0%, below estimate. Year-to-date collections are \$362.7 million, or 3.1%, below the official estimate.
- Realty Transfer Tax (RTT) revenues of \$46.8 million were \$0.1 million, or 0.1%, below estimate. Year-to-date collections are \$67.8 million, or 13.8%, below estimate.
- Inheritance Tax revenues of \$83.7 million were \$2.5 million, or 2.9%, below estimate. Year-to-date collections are \$25.1 million, or 2.9%, below estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Table Games, and other miscellaneous tax collections totaled \$160.2 million for the month of May.
- Nontax revenue collections for the month of May were above the official estimate by \$38.4 million. Year-to-date collections are \$6.1 million below the official estimate.

MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of \$265.4 million in May were \$4.1 million, or 1.5%, below the official estimate. Fiscal year 2016-17 collections of \$2,501.3 million were \$4.8 million, or 0.2%, below the official estimate.

The State Gaming Fund collected \$76.6 million in May. Fiscal year-to-date collections for the fund total \$723.1 million.
