- MOTOR LICENSE FUND COMPARISON OF ACTUAL TO ESTIMATE MAY 2019


## GENERAL FUND

General Fund collections of $\$ 2,616.3$ million for the month of May were $\$ 14.9$ million, or $0.6 \%$, below the official estimate. Fiscal year 2018-19 collections of $\$ 31,779.3$ million were above the official estimate by \$813.3 million, or 2.6\%.

- Total Corporation Tax collections of $\$ 344.7$ million for the month of May were $\$ 47.3$ million, or $15.9 \%$, above the official estimate. Year-to-date collections are \$590.6 million, or $13.6 \%$, above estimate.
- Sales and Use Tax (SUT) collections of $\$ 944.8$ million were $\$ 46.7$ million, or $5.2 \%$, above estimate. Year-to-date collections are $\$ 320.6$ million, or $3.3 \%$, above estimate.
- Total Personal Income Tax (PIT) collections of $\$ 966.0$ million for the month of May were $\$ 42.2$ million, or $4.2 \%$, below estimate. Year-to-date collections are $\$ 82.8$ million, or $0.6 \%$, below the official estimate.
- Realty Transfer Tax (RTT) revenues of $\$ 46.9$ million were $\$ 7.0$ million, or $13.1 \%$, below estimate. Year-to-date collections are $\$ 28.2$ million, or $5.6 \%$, below estimate.
- Inheritance Tax revenues of $\$ 101.9$ million were $\$ 2.8$ million, or $2.7 \%$, below estimate. Year-to-date collections are $\$ 27.0$ million, or $2.7 \%$, below estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Gaming, and other miscellaneous tax collections totaled $\$ 178.2$ million for the month of May
- Nontax revenue collections for the month of May were below the official estimate by $\$ 54.3$ million. Year-to-date collections are $\$ 41.7$ million above the official estimate.


## MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections previously reported as Liquid Fuels and Fuels are now reported under Minor and Repealed.

Motor License Fund collections of \$296.3 million in May were \$7.9 million, or 2.7\%, above the official estimate. Fiscal year 2018-19 collections of $\$ 2,604.4$ million were $\$ 47.9$ million, or $1.8 \%$, below the official estimate.

The State Gaming Fund collected $\$ 69.9$ million in May. Fiscal year-to-date collections for the fund total $\$ 739.3$ million.
